Early on in the financial debacle that will result in a massive federal bailout of private business, Senator John McCain stepped forward forcefully ... to declare his opposition to the bailout of AIG. Then, of course, he reversed himself.

Then he rushed the barricades to announce that he was going to ride onto Wall Street after he is elected president and regulate the heck out those ol' boys. Then he blamed Barack Obama for placing the country in this dilemma.

Regulation, said the senator who chaired the Commerce Committee for so many years and advocated deregulation in 1999, is the only thing people on Wall Street could possibly understand.

Then he said the \$700 billion bailout was necessary and should be enacted swiftly, then he said he had doubts about the way it was structured without oversight.

While McCain was flopping around trying to figure out which way the wind was blowing, this is what Mr. Regulator wrote in the current issue of Contingencies – the magazine of the American Academy of Actuaries: "Opening up the health insurance market to more vigorous nationwide competition, as we have done over the last decade in banking, would provide more choices of innovative products less burdened by the worst excesses of state-based regulation."

Whatever happened to the straight-talking McCain of 2000?

If Congress gives the Treasury Department the authorization to spend \$700 billion without establishing oversight of the people administering these funds, both sides of the aisle will live to regret their largesse.

Philosophically, it is a difficult choice for both parties – the Democrats are cringing at the thought of bailing out Wall Street, the Republicans are aghast at the idea that the government is going to expand into yet more private enterprise.

Both parties, however, should keep in mind the fact that the congressional soul was handed over to the devil with the Authorization for Use of Military Force Against Iraq Resolution of 2002. In that document the Congress permitted the president to use the armed forces "as he determined to be necessary and appropriate to defend the national security of the United States against the continuing threat posed by Iraq. (Italics ours).

Congress found itself unable to stop payment on that blank check when it realized that Iraq posed no threat.

Now, the draft resolution for the \$700 billion bailout allows the Secretary of the Treasury (who had been doing his "don't worry, be happy" jingle about the financial condition of Wall Street for his first 18 months in office until last week when he morphed into Chicken Little) to act without any interference from the legislative or judicial branch.

"Decisions by the Secretary pursuant to the authority of this Act are non-reviewable and committed to agency discretion, and may not be reviewed by any court of law or any administrative agency." (Italics ours).

Why is that clause necessary? Why would the taxpayers not want a system of checks and balances as provided for in the Constitution? Why would legislators continue to cede authority to the executive branch and stand by while Bush and Cheney gobble up power?

Democratic congressional leaders are balking – a bit – at this provision but are wary of stalling the process. What's the reason for the urgency?

This weekend, Congress is schedule to go into recess for the election season.

know how many special units we have in Lucas County? This will be just another kingdom-building enterprise over the years.

The LCIC has not worked well not because of a lack of funding but because of the distrust endemic among different levels of government in Lucas County, especially among the townships. As long as the townships distrust the cities, our LCIC will not work. And the mayors of cities such as Oregon and Maumee will not let Toledo show them up. In fact, Oregon likes to stick it to Toledo whenever it can. Believe me, I have been there and observed that friction first hand.

Former University of Toledo President Dan Johnson is returning to the ranks of university presidents as he plans to take a job in Dubai. Dubai's gain will be Toledo's loss.

However, I disagree with Johnson's recent recommendation of the Lucas County Improvement Corporation (LCIC) to be funded by increasing the county fee for conveyances. This will start out at \$800,000 and grow in the coming year.

The problem is that Lucas County does not need another separate special use tax district. Most observers of metropolitan government lament the increase of governmental units. Does anyone

speaking of our neighbors, the single greatest threat to Toledo emerging as a stronger city is the proposed merger between Sylvania and Sylvania Township. When that happens, watch out! The new combined city will emerge as a much greater force in county and state politics. This is where the middle class and entrepreneurial couples are moving to live - not to Toledo.

Last week, I attended a fundraiser at the Monclova

Township Junior High School. I had not been that far down on Monclova Road in nearly eight years. I was stunned by the level of development. Just rows and rows of houses from St. Luke's Hospital to the junior high.

This area will emerge as another power center because of the population increase.

We keep wondering how Senator Barack Obama might lose northwest Ohio. If you can picture the county in your mind, just start with the area you and I call Trilby. Go west, then south to Bowling Green. All those folks are GOP. And the farther west you go toward Indiana, the more Republican it gets.

We sometimes think that the voting world is central Toledo. Nope, that is just a small part of northwest Ohio. That's why every vote in the central city counts.

Feds Step In to Avert Worst Financial Crisis Since Great Depression

"The era of big government is over," proclaimed President Bill Clinton in 1995. Even if one were to take that statement at face value, the era of small government was short lived. Big government can roaring back with a vengeance this week as federal lawmakers and the Bush administration worked to put together a \$700 billion bailout of companies holding distressed mortgages.

The details were still being worked out at the beginning of the week particularly as Democrats on Capitol Hill attempted to write provisions into the legislation that would provide help for individuals and would provide oversight on those administering the funds.

Democratic congressional leaders were particularly leery of handing over to the administration the same type of unfettered power that the legislators handed over to the executive branch in the months following 9/11. They

have felt duped ever since over federal excesses committed in the name of the Patriot Act, for example.

"We were days away from financial catastrophe," said Treasury Secretary Henry M. Paulson, Jr. during one of his many appearances on the Sunday talk shows as he tried to defend the bailout plan.

Paulson emphasized that speed and simplicity were the keys to salvaging financial markets from collapse. "First, we are stabilizing the markets, then we need to ask ourselves how we got here. We need a lot of reforms, these are the things that Congress and the next administration will be working on for a very long time.

The Democrats, and millions of Americans, questioned the need to bail out Wall Street without giving due consideration to Main Street in the same legislation. Paulson made it clear that Main Street – individuals of all stripes – would be directly

impacted by the failure of financial markets through the devaluation or potential loss of jobs, retirement accounts

and college fund accounts.

"It's about protecting our economy; it's about protecting our jobs," said Congressman John Boehner (R-OH), minority leader in the House of Representatives and a conservative committed – at least in the recent past – to the concept of limited government. "This is about our way of life, it isn't about Wall Street. It's the most serious financial crisis the world has ever dealt with."

That financial crisis has its origins in the speculation in real estate that began about eight years ago as financial institutions started offering billions of dollars in subprime mortgages around the country. Those mortgages were eventually purchased by large investment houses and secured by the public/private hybrids Fannie Mae and Freddie Mac.

As home values began dropping two years ago, the problems with the mortgages were exacerbated and along

with a flurry of foreclosures around the nation, the financial giants started writing off their losses.

In March Bear Stearns, an investment bank founded in 1923 which had survived the Great Depression without laying off any employees, almost collapsed before JP Morgan Chase stepped in and purchased the investment house. In early September, the government put together a plan to save Fannie Mae and Freddie Mac from collapse with up to \$200 billion in financing and placing the companies into a government conservatorship.

Days later, the government put forth \$85 billion to rescue American International Group (AIG), an insurance group that was on the verge of bankruptcy.

But last week, disaster struck as Lehman Brothers, employer of 25,000 worldwide, declared bankruptcy – the largest bankruptcy filing

in U.S. history – and Merrill Lynch sold itself on the cheap to Bank of America. Both Lehman Brothers, founded in 1850, and Merrill Lynch, 1914, had also survived the Great Depression intact.

Congress was sold on the bailout package last week when Paulson and Federal Reserve Chairman Ben. S. Bernanke held a meeting with leaders on Capitol Hill and informed them of the overall urgency of the situation. Congressional leaders were impressed by what were predicted to be the trickle down impacts of the financial crisis on Wall Street to individual Americans.

The long range effects of the bail out are a matter of much speculation.

The government will now be in the business of holding assets – bad assets at the moment – that it can sell as time goes on. If the markets respond favorably in the long term to the purchase of these so-called illiquid assets, the takeover could be profitable for the American citizens. No one is counting on that happening. But the ultimate costs should be below what

the assets were purchased for, said Paulson on Sunday.

The fast-moving government actions kept the presidential candidates off-balance for the most part.

Democratic nominee Senator Barack Obama of Illinois gathered together his financial team – including people such as investor Warren Buffet, former Fed Chairmen Paul Volcker,



former Treasury Secretary Robert Rubin – and announced that he would support the proposal in general but asked for a broader economic stimulus package as part of the bailout. He declined to put together an alternate plan of action and deferred instead to Congress and the administration.

Republican nominee John McCain of Arizona, a long-time supporter of de-regulation in the banking industry, at first opposed the AIG bail-

out, then supported it and finally re-cast himself, by the end of the week, as the regulator Wall Street would grow to fear. He also called for the president to fire the head of the Securities and Exchange Commission, Christopher Cox, before acknowledging days later that the president was not so free to simply fire the head of a semi-independent agency.

Whatever happens as the final shape of the bailout is hammered out in negotiations between Congress and the administration, it is clear that the face of Wall Street will be irrevocably altered. The remaining two giant investment firms – Goldman Sachs and Morgan Stanley – have decided to forego their comparatively unregulated status and join the ranks of commercial banks.

Such a change allows them to seek, when necessary, greater federal protection but also requires them to undergo more intense federal scrutiny. As a result, both banks will be taking substantially fewer risks in the future.

There Is Help in The City of Toledo for Those Facing Foreclosure

There are several entities in Toledo that can help home owners who are facing the possibility of foreclosure.

The Fair Housing Center offers two programs, with another one coming on board soon, to those who qualify for assistance.

Through the Ohio Department of

Development's Office of Housing and Community Partnerships and the Toledo-Lucas County Housing Fund, the Fair Housing Center has a grant for free emergency mortgage assistance for up to three months back payments if you meet the following criteria: the loan is predatory, your income is up to 80 percent of the Area Median Income, your home is owner-occupied, your home is in Lucas County, you can show that once you receive assistance you are able to resume and maintain mortgage payments and you commit to 24 months free Financial Counseling Services.

Through a grant from Lucas County Job & Family Services, the Fair Housing Center has a grant for those who meet the following criteria: your home is in Lucas County, the home is owner-occupied, the loan is in arrears at least two months, you make less than 300 percent of federal poverty level, you have a minor child (or you are an 18-year old full-time student or pregnant or have a non-custodial minor dependent within Ohio on child support plan), you can show ability to resume and main-

tain payments, commit to attend a Case Management Interview, commit to attend a Fiscally Fit credit training class.

According to Fair Housing's Michael Marsh, the Center will soon be receiving a grant from the Federal Home Loan Bank of Cincinnati through National City Bank to assist 28 families in the area.

"It's not out main mission but it's what so many people need help with now," said Marsh.

Other agencies offer a variety of services that may enable the lender to avoid foreclosure.

Fair Housing can be contacted at 419-243-6163. The City of Toledo's Department of Neighborhood suggests the following steps to take and agencies to contact:

- Get an Attorney
- Retain a union attorney if that option is available.
- Seek free legal assistance

(NODA)(419-243-3734) or Advocates for Basic Legal Equality (ABLE)(419-255-0814)

Call the mortgage company immediately and speak to the Loss Mitigation Department and try to re-negotiate the monthly payment and interest rate.

Toledo CDC and Toledo Urban Federal Credit Union Partner in Housing

From all we know about what is happening with the large investment houses and the companies that guarantee loans, the housing market is in pretty abysmal shape these days.

However, the reality of the situation is that housing prices have dropped about 15 percent in the last two years and, because it is so difficult to obtain financing, there are deals aplenty in the housing market. You just have to be able to get that mortgage.

The Toledo Community Development Corporation (CDC) and the Toledo Urban Federal Credit Union (TUFUCU) have joined forces to enable Toledoans to do just that.

According to Suzette Cowell, president and CEO of TUFUCU, which just recently entered the mortgage business, TUFUCU can be a bit more flexible with credit requirements than the average bank is these days.

Some potential buyers might even qualify for down payment assistance, says Cowell.

The Toledo CDC has what Executive Director E. Mickens calls "the jewel of the jewels" for sale in the Englewood Historic District on West Woodruff.

The object of Mickens' affection is a four-bedroom, three-full bath, two-story, 1,600 square-foot home with a detached two-car garage built by Stanberry Homes, Inc. The house will sell for \$125,000 to some lucky buyer even though it has been appraised at \$135,000.

There's more. The buyer will also receive a 15-year tax abatement for further savings.

The energy-efficient home is ready to be moved



into, says Mickens of the property located in the midst of a stable neighborhood with well-kept houses.

The fully-carpeted house has a bedroom on the first floor and a ramp leading from the garage to the house,

making it completely accessible.

It also has a full basement.

Mickens and Cowell estimate that monthly payments, with a minimum down payment on a 30-year mort-

gage, would be \$831 but that amount would decrease for a buyer eligible for down payment assistance.

Port Kicks Off 2008 Renewal Levy Campaign

Funding Needed to Continue Economic Development and Job Creation Efforts

The Toledo-Lucas County Port Authority today kicked off their 2008 levy campaign in pursuit of a five-year 0.4 mill renewal levy that provides funding for local transportation and economic development efforts. The levy is not a new tax and will not cause taxes to increase if it passes.

The Port Authority currently receives approximately \$2.4 million annually through the 0.4 mill levy, accounting for eight percent of the total annual budget.

ties along the Maumee River, remediation of brownfields to provide clean and viable land for development and neighborhood revitalization projects led by local non-profit community organizations.

Levy Co-chair Alex Johnson of Midwest Terminals said "The Port Authority works collaboratively to pool available resources to ensure Lucas County is an attractive place for new business to set up shop and for existing business to want to

ledo Urban League echoed the statement, adding "The Port levy also helps make funding available for local businesses. They support bonds and loans for small and large businesses at low rates that they may not be able to receive through the regular market. The Port is helping our community to help itself by building business and creating jobs in all sectors of the workforce in Lucas County."

Oregon Mayor Marge Brown emphasized her support for the levy, noting that the investments the Port makes are not just in Toledo – and they benefit the entire county. "The Port is using the tax dollars from this levy to clean up land and make it available for development. They're improving streets and sewers in undeveloped area to make it accessible for businesses looking for a place to grow. These are real bricks and mortar projects that benefit all of us around the entire county, and they create good-paying jobs in the process."

Sonia Troche, executive director of Adelante agreed with the mayor, but noted that aside from bricks and mortar projects that directly benefit businesses – the Port also uses levy funds to support projects that make Lucas

County and attractive community for business. "The levy helps fund neighborhood revitalization projects that will attract or retain business in Lucas County and facilitate new employment opportunities. All of these services are pumping money and jobs back into our local economy. It's building our neighborhoods from the ground up."

Issue 41 will be on the November 4, 2008 general election ballot. The levy costs the owner of a \$100,000 home approximately \$6.60 per year. It is not a new tax and will not increase taxes if passed.

“Deconstructing Sammy” by Matt Birkbeck

Do you remember Matthew Beard?

How about Louise Beavers? Leo Gorcey? What about Ann Blythe, Michael Callan, or Pete Duel?

Those people were once big Hollywood names, but unless you're of a Certain Age or are a student of stardom, you probably don't recognize them.

In the 1950s and 60s, singer/dancer/actor Sammy Davis, Jr. was one of America's best-loved performers but you rarely hear much about him these days. In the new book **“Deconstructing Sammy”** by Matt Birkbeck, you'll see why.

Three years after Sammy Davis, Jr. was born, his parents divorced and his father took Sammy on the road.

Though he would forever lack a formal education, it was quickly apparent that the child was talented; he was able to mimic almost every performer he saw.

Because he and his father had performed as the opening act for many big names, Sammy's star rose quickly. He became friends with Frank Sinatra and, later, with other major stars of the era.


For two decades, Sammy Davis, Jr. was one of America's top entertainers. In the 1970s, though, his audience-drawing ability began to wane. He got involved in some iffy business deals and made several bad financial decisions. When he died in 1990, Sammy Davis, Jr.'s estate was a mess and his entertainment legacy all but gone.

Four years after Davis' death, Sonny Murray, a Pennsylvania lawyer, told a friend of his father's that he would take the case of Altovise Davis, wife of the late star. Mrs. Sammy Davis, Jr. had a noticeable problem with alcohol and she was in ill health. Worse, she was in deep debt and in trouble with the IRS.

For years, Sonny worked on behalf of Altovise Davis, trying to clear up her debts. He became obsessed with re-establishing Sammy Davis Jr.'s amazing legacy, and he worked with little or no pay to do it, often, according to Birkbeck, with little or no help from Altovise.

In the end, the life and death of a singer consumed the life of the attorney.

With a journalist's eye toward a great story, author Matt Birkbeck leads readers through a decades-long financial mess including cover-ups, deals that obviously took advantage of Sammy, mob connections, political friendships and snubbings, and contractual issues that affected the singer's life and estate, including some with several players who appeared to have been playing the famous performer.

While Davis' life-story is un-put-down-able, though, Birkbeck's portrayal of Sonny Murray is absolutely stunning. It's a tale of obsession, legal wrangling and wanting to do the right thing despite the roadblocks erected by the very people who would have benefited most from Murray's work.

If you love a good scandal, a good story or a great bio, you're going to want to read “Deconstructing Sammy” soon. Remember this one on your next trip to the library or bookstore.

Grandparents who find themselves primary caretakers for young children or, in some cases teenagers, are faced with a large set of problems, especially if many years have passed since they've had children in their homes.

A grandparents' support group has been active in the Lima area for a number of years thanks to Rev. William and First Lady Marilyn Taylor. The group meets consistently to offer comfort, advice and information. Members come and go as their need demand, but even though the Taylors have raised their children and grandchildren, they continue to host the meetings in their homes, because the need for support never changes.

According to the Ohio Department of Aging statistics, in 10 percent of Ohio household, grandparents filed as primary caregivers to youth. The concerns raised by those over 65 included in very large numbers the health and overall well-being of their grandchildren.

The information gathered by the state factored in reasons given for this arrangement: the actual parents are unable or in some cases unwilling to care for their own children. Substance abuse, divorce, separation, unemployment, abandonment, teen pregnancy, finances, death, physical or mental illness, homelessness, child abuse/neglect, pursuit of higher education and incarceration were all cited as events leading to grandparents taking on the responsibility of these children.

The average age of a grandparent raising a grandchild in Ohio is 55, though there are many who are over 65, and more than half of these have grandchildren age six or younger.

Ohio's statistics paint a picture of financial burden in these households as well: "As primary caregivers, grandparents often face formidable challenges. More than half have annual household incomes below \$30,000; 25 percent have annual household incomes of less than \$15,000. Only 11 percent are legal guardians for the children; just nine percent have formal temporary custody. Nine percent receive child support, 14 percent receive financial support from public assistance and eight percent receive social security for the child." (Ohio Dept. of Aging 2008)

Help for these citizens is limited and their designation as grandparents without guardianship creates an even larger burden when trying to deal with the school or court systems. Little financial help is forwarded because of this status creating an even heavier burden on those already living on fixed incomes.

"It's just too much to ask. They shouldn't be going through all this at this stage of their lives," said Austin. "We love them for taking on the challenge. We love them, because their love is boundless - I never knew my grandfather, but my grandmother I love her with all my heart. But, she's done with her responsibility. She did a great job, but now it's my turn."

Austin knows the burden

and challenges personally, his nieces and nephews are under the primary care of his mother since January 4, the night Police Sergeant Joe Chavali shot his sister, Tarika Wilson. "We've got to turn things around," he said. "Sometimes, the situation is out of our control and grandparents have to step up and care for the children, but for those of us that can take care of our own ... it's time for us to meet the responsibility face to face."

The Grandparents Day dinner included a tribute to and from one of Lima's most valuable treasurers, Georgia Newsome, local author, poetess and historian.

She greeted the audience crediting her involvement with young people for helping to keep her 80 years young. As

she read from her yet-unpublished book, *Tales from the Porch*, smiles could be seen in faces across the room.

"This is part of our legacy and it's an honor to host this event, I'm happy to do it," said Glenn. "I've got a great crew that helps me every year, and we're going to keep doing it

every year, because it's important to let the people know how much we appreciate all that they do in the sixth ward."

Councilman Glenn, his wife and a small group of volunteers continued their tradition again in 2008, honoring grandparents and celebrating their boundless ever-lasting love.



"As grandparents you are there to love the children, offer advice and you should have them in your care whenever you want to but not because you have to," Ivory continued. "You've done the job of raising your children, now it should be your turn to relax. But, too often you don't have the choice."

The event drew a large crowd this year in the common room of Lima Towers located on South Main Street. As Austin spoke, there were a lot of nods in agreement as Tower residents and guests for the event itself thought of their own experiences or those of their neighbors and families.

"My daughter is having a really hard time dealing with life right now," said Deloris Makley a grandparent of six.


