

This Strikes Us ...

Take Advantage of the Opportunity to Vote Early

Voting cannot get any easier than this – from now through Monday, November 3, registered voters who reside in Lucas County can cast their votes prior to the Election Day crush at the EMS Training Center at 2127 Jefferson.

There have been approximately 700,000 potential new voters registered in the run-up to the 2008 general election, most in predominantly Democratic strongholds such as Lucas County. Voting early will help alleviate some of the problems that plagued urban areas in particular in 2004.

Several Truth staffers voted last week and we can assure those of you who question whether such a move makes sense, put your doubts aside. It is convenient, fast, thoroughly staffed with knowledgeable workers and, above all, you have choices.

First of all, it's a great parking situation. Unlike what has happened at Government Center in the past, the EMS Training Center has its own lot – and it's free. People are moving in and out so quickly, there seem to be plenty of empty spaces. The ring immediately surrounding the EMS Center might be full but there is an auxiliary lot adjacent to the ring.

Inside the Training Center, the poll workers are numerous and efficient unlike what often happens in polling places on Election Day. You are guided every step of the way. First someone greets you to assist. Then you are directed to several workers who take your information and verify that you are indeed registered.

Unlike what will occur on Election Day, you do not need to show identification (bring it anyway, however, just in case there is some snafu with your registration and if you cannot remember your driver's license number or your social security number.)

You will be given a form to fill out—the application form to vote early and on which you will verify those numbers. Then you will be guided to the workers who are distributing ballots—eight to 10 of them on the day we voted—and who will give you a choice of how you want to yote.

We hear so many folks these days talking about their fears that an early vote may be lost of not counted. In the past, this has usually been the case for provisional ballots more often than early ballots. Provisional ballots, by the way, are filled out by voters whose names do not appear at a polling place because: (1) they are at the wrong polling place, (2) they are not registered or (3) they have moved or changed their names.

Generally the problem that has occurred with early, or absentee ballots, is that the ballots are not properly placed in the envelope or not properly completed. This has rarely been a problem for those voters at the polling site because they are instructed on placing the ballot in the envelope. It generally happens with those who actually do mail in their ballots because they are indeed absent. Even this issue has been addressed this year with a change in the size of the envelope.

Nevertheless, these days when you vote early, you have a choice – you can use the paper ballot or you can use the touch screen – just as on Election Day.

There is an abundance of touch screens and they record and store your vote just as they will on Election Day. So if you fear the paper ballot getting stuck in someone's attic, don't worry about that.

If, however, you fear the touch screen process, you have a choice. And, once again, keep in mind that we don't have any history of problems with paper ballots that are properly completed.

The advantages to early voting should be obvious. You will avoid the Election Day crush, of course. You will also have more flexibility with the hours. There is far less chance for error because the poll workers are overworked or under trained. Don't worry about a machine breaking down during the early voting process.

Who knows what can happen on any given day, such as Election Day - illness, transportation issues, overtime, forgetfulness \dots

At the EMS Training Center, you can vote from 8:30 a.m. to 7:00 p.m. from Monday through Friday. During the last two weekends before Election Day, the site will also be open – from 8:00 a.m. to 4:30 p.m. on the two Saturdays and from 1 p.m. to 5 p.m. on the two Sundays.

Don't take the chance. We have never been presented with such clear-cut choices or a more meaningful election in such a crucial time.

The new HIV infection
rates, as reported by the Centers for Disease Control (CDC)
are simply devastating. Make
no mistake - this is a political
issue. It is a social issue. It is
both a black community issue and a global issue. It is
for some – a moral issue. But
beyond whatever label you
put on it – it is a life and death
issue. Either you do some-

First, in the United States alone, more than one million people are living with HIV and/or AIDS. So, it's not a silent epidemic. It's likely right in front of your face – whether it's your neighbor, your cousin, your brother, or your grandmother—HIV and/ or AIDS' close proximity to you means that you have access and opportunity to substantively make a positive contribution to the lives of those who are HIV positive

thing about it or you don't. I

hope you choose the former.

Here's why you should.

Second, your participation would create an opportunity for education. Among other things, you will learn from your entre into the science of the epidemic that HIV and AIDS are not medically the same. In terms of the field of medicine, HIV is a virus that attacks your immune system and can develop into AIDS. However, it does not have to. And, thanks to medi-

cal and antiretroviral advances over several years, many afflicted with the condition live 'normal,' healthy lives and potentially may never develop AIDS in their lifespan. True - for others, depending on the strand of infection, time of diagnosis and infection, etc. one's prognosis may differ. But, the point is, proper education is needed so we can become better equipped with the appropriate knowledge. For the purposes of this article, I deliberately refer to the epidemic as HIV and/or AIDS versus just AIDS or HIV/ AIDS because of the medical distinction.

Third, the knowledge is needed to help stifle the stigma. This stigma is present nearly everywhere a person afflicted with HIV travels. While it is not as bad as it once was when, say, the Tom Hanks and Denzel Washington movie *Philadelphia* debuted (which is 'celebrating' its 15 anniversary this week)—the stigma, however, is still bad. If many feel they can not talk about it, how well do you think they are addressing it?

Frankly, we need to fight the stigma. It must be a topic of ministers' sermons—regularly (not just during certain holidays and events). It should have long become an issue of concern to the Urban League and the NAACP.

And by concern, I mean, a proactive method of attention that includes preventive methods and serious steps at intervention - intervening in the lives of those afflicted with care and support (financial and emotional). I don't see that. Many of our black organizations have simply failed. And, honestly, many churches are the main culprits. Ministers need to get beyond the sexual orientation doctrines that they attribute to the epidemic. Why?

Because, globally, more people contract the disease through heterosexual contact than through any other means. In addition, the last time I checked. God asks us not to judge but to love. You can still pray for someone with HIV, attend to someone with HIV and their needs, and hold true to your doctrine, without asking how they contracted the disease, if they're gay, etc. The fact is - you don't need to know to care for the individual. And given the statistic I just highlighted, they likely won't be gay, anyway.

Bottom line – HIV and/or AIDS and homosexuality are not synonyms and are not necessarily related.

While I will debate a minister theologically if he or she holds a position on sexual orientation that denies equal rights to those not hetero

Republicans' Attempt to Disenfranchise Voters Thwarted by Ohio Supreme Court

Recently, the Ohio Supreme Court, in a four-tothree decision dealt a serious blow to the Ohio Republican Party's efforts to disenfranchise hundreds of thousands of voters and at the same time vindicated Secretary of State Jennifer Brunner's efforts to ensure that all Ohioans have equal access to the polls.

The Republican-dominated Supreme Court proved to be a check on Republican efforts to cause voter confusion with frivolous lawsuits. Additionally,

United States Northern District Judge James S. Gwin ruled that Brunner was properly upholding Ohio election laws in stating that the Republican position "would lead to illogical results, potentially disenfranchising large numbers of voters."

In issuing this ruling, these courts have clearly rebuked the Ohio Republican Party for employing blatantly partisan tactics toward Secretary of State Brunner. With the presidential election fast approaching, Ohio Republicans have been ramping up their attacks on Brunner daily.

Such attacks have led to accusations of Brunner attempting to disenfranchise voters and allegations that she has and will continue to break state election laws unless stopped. This is the same Republican Party that purposefully challenged thousands of voters in 2004

based solely on undeliverable pre-election mailings and wanted to void new voter registrations not printed on 80 pound paper. The courts have now unveiled this blatant Republican hypocrisy.

This issue of same day absentee voting has appeared to enrage Republicans. Secretary Brunner's directive instructed local Boards of Election that during the five day overlap between the end of voter registration and the beginning of absentee voting, newly registered voters should be provided absentee voting ballots if requested.

In response, Republicans engineered lawsuits in a poor attempt to question Brunner's directive and to make the case that Secretary Brunner's effort to guarantee more Ohioans access to voting is somehow illegal. Despite challenging Secretary

Brunner's directive, it was reported by the Associated Press on September 29, 2008 that the GOP's own web site was encouraging their voters to take full advantage of the five day overlap to register and cast an absentee ballot. Apparently Republican hypocrisy knows no bounds.

Two courts validated Secretary Brunner's interpretation of the law to favor voter's rights. I am not alone in my perspective on this dispute. When asked about the Republican's law suit against Secretary Brunner, election law expert and Associate Director of Election Law at The Ohio State University's Mortiz College of Law, Daniel P. Tokaji, commented that "Brunner's interpretation of Ohio law is precisely correct and the Republican's position by contrast is in direct conflict with the laws they have

passed and in conflict with federal voting rights laws."

If the Republican's reading of the law were upheld there is no doubt that a large segment of the potential voters would be prevented from voting – directly in opposition to the ultimate goal of no fault absentee voting.


In responding to a question about the possible motivation behind the Republican's law suit against Secretary Brunner, Professor Tokaji stated, "This is voter suppression in as naked a form as we've seen in Ohio for years, Republicans are trying to manipulate the court to their own partisan ends."

The fact remains that the no-fault absentee voter law in question was in effect during the 2006 primary and general elections and during that time, Republicans never raised concern re-

garding the registration overlap. The purpose of this law was to make the voting process easier and more accessible to all Ohioans. In fact, no-fault absentee voting was introduced by Republican legislators and signed into law by former Republican Governor Taft.

I am proud of the Ohio Supreme Court for seeing the Republican lawsuit as frivolous, designed to cause elector confusion. Such Republican lawsuits represent a step back from voter inclusion and a step towards blatant voter suppression. Such attempts leave one question yet to be answered: Why are Republicans so afraid of fair and open elections?

Among the local Latino officials in attendance was


Anita Lopez, Lucas County Auditor, who noted her pride in having such a positive Latino role model elected to the Congress.

UT Professor Fights Child Sex Trafficking in Lucas County

Nearly three years after federal investigators broke up a major child sex trafficking ring with ties to Toledo and the Midwest, many residents are still perplexed as to how and why Toledo became a major hub for teenage prostitution recruitment.

Celia Williamson, University of Toledo associate professor of social work, attempted to answer these questions, and others, on Thursday, Sept.18

lieving that he is her boyfriend and that he has her best interests at heart.

Williamson says this type of "pimping" seems to be more respected in the world of child sex trafficking, because these pimps makes his victim believe that she is making all of the decisions affecting her life.

Unfortunately, once these teens fall prey to these pimps, they are taken to truck stops and "cat-houses" in various

the local FBI Task Force, she feels the Toledo Police Department has a ways to go in terms of recognizing and preventing child sex trafficking in Lucas County

Williamson also addressed the need to re-evaluate Lucas County's current system of social services in hopes of adequately addressing and meeting the needs of victims of domestic sex trafficking.

Inthemeantime, Williamson is doing her part to end child sex trafficking by offering girls at risk of being victims of domestictrafficking and girls who have been victimized by domestic sex trafficking, free comprehensive services including intensive case management, advocacy, education and prevention and trauma treatment through one on one counsel-

Braden's 100th Anniversary: Reflections of the Past, Embracing the Future

Braden United Methodist Church is celebrating its 100th anniversary in 2008 and this upcoming weekend – centennial banquet on Friday and Anniversary Sunday service – will be the culmination of a monthlong series of events that has featured former pastors coming home to preach in the Braden pulpit.

"Braden owes it origin to a small group of dedicated Christians who became the nucleus to organize a Methodist Church in Toledo, Ohio sometime during the year 1908," proclaims the account that Braden historians have compiled.

The original group had met for some time prior to 1908 in various homes as a prayer band. During that year, the group found a home on Canton Street and named their new church the Canton Street Mission under the auspices of the Methodist Church system. Mr. and Mrs. Louis Allen, Beverly Harris, Bettie Williams, Charles Thomas, Anna Bland, Mary High, George Weatherly, Lela Harris and Mayme Smith were some of the persons in that founding group.


The Lexington Confer-

ence of the Methodist Church dispatched Rev. George Chinn of Columbus to pastor the Canton Street Mission.

As the black population of Toledo grew during those early years, so did the Mission. "From what I have heard, when people came here from down South, Braden was one of those churches that opened their doors to them," says Rev. Wynston Edward Dixon, who has been the pastor at Braden since 2005.

Rev. Charles Johnson followed Chinn in 1918 and in 1920 the congregation moved to a new location at the corner of City Park and Belmont Avenue. A new structure was completed on that site in 1924. During the dedication of the building, the church was renamed "Braden" in honor of Dr. John Braden, president of Walden University of the Methodist Church of Nashville. TN.

The congregation remained in that one-room structure until a new, more spacious church building could be found on Lawrence Avenue in 1956. The new building was purchased during the tenure of Rev. I.R. Shumer but the major

fundraising had been started earlier under the leadership of Rev. George W. Sherard.

Of the many significant periods in Braden's history, certainly one of the most outstanding, and memorable, is that period when Rev. Albert L. Reed served as pastor – from 1966 to 1986 – the longest tenure by far of any pastor in

during a time when challenges to the nation's history of racial discrimination were at a peak.

In all, 18 pastors preceded Dixon in the pulpit. The first pastor, George Chinn, served for 10 years during a time of financial burdens and other seemingly insurmountable hardships, according to church history. But over the years, the congregation grew and thrived. The current membership, says Dixon is about 400 with close to 200 being active.

Dixon earned his bachelor's degree in theology from Cuttington University College in his native Liberia. There are no graduate schools in Liberia, so Dix on came to the United States in order to attend Southern Methodist University to obtain his master's of divinity. He was ordained as an elder in the United Methodist Church in 1990 and served stints in both Cincinnati and Columbus, OH before being assigned by the church to

Toledo – first Asbury United Methodist, then Braden.

For Dixon, the ministry has been his calling for about as long as he can remember. "I was always a boy who dreamed - from the sixth grade - of joining the ministry," recalls Dixon. "I was greatly influenced by my bible teacher and that helped answer the call I saw for my life. The ministry is something I've done all my life." In fact other than a brief time with UPS during his SMU days, Dixon has held no job other than the ministry

But even though much of his family is now in the United States including his daughter Wynlita, a 15-year old student at Whitmer High School, and his three brothers, who reside in Florida, Delaware and Maryland, Dixon has every intention of returning home to Liberia once the country has put its 14-year civil war behind it and has settled into peace and tranquility.

"It was my goal to come here, study and go home," he says of the original plan. "I left right after the coup but things never settled down. My ultimate, utmost goal is to return home and to continue a contribution. I can do some ministry there and my conference needs me in Liberia. The continent is so ripe for ministering and Christianity is growing faster than any other religion. They need qualified pastors."

Braden, meanwhile is reflecting on the past while embracing the future. The church of today has 19 ministry teams that involve congregants of all ages and interests.

"We have accomplished deeds that are well pleasing to Our Lord," says Vince Davis, chairman of the centennial committee. "We help guide ordinary people to eternal salvation. That is the essence of being a Christian."



Ohio Once Again The Focal Point of a Presidential Campaign

Rep. James Clybum (Dem-OH), the third-ranking member of the congressional Democratic Party caucus as majority whip, was in Ohio campaigning last week in the wake of the House approval

of the Wall Street bailout plan.

"I've seen tremendous enthusiasm," said Clyburn of the political atmosphere in the Buckeye State and around the country. "After the [first] debate, the rest of the country now sees assurances that [Senator Barack Obama] is ready to be president. He also looked like he was ready. The enthusiasm I see now in Ohio is not what I saw four and eight years ago. This is a level of enthusiasm I did not see before."

Following closely on Clyburn's heels were veteran rock 'n roller Bruce Springsteen over the weekend and hip-hop impresario Russell Simmons.

Simmons appeared at an African American media forum and reception in Colum-

bus on Saturday and then, with homegrown celebrity Lebron James, in Cleveland on Sunday.

"We have to change," Simmons told the roomful of journalists. "I resigned from the Hip-Hop Summit to work for this campaign and to tell young people you can't get unless you give."

And, on Monday, movie star and Academy Award winner Cuba Gooding, Jr. came to Toledo as part of his own Ohio tour to urge folks to get out and vote. Gooding spoke briefly to a gathering at the Laborers 500 Hall in the Bill Copeland Building on Ashland before leading fans and voters over to the EMS Training Center on Jefferson.

"I was so frustrated with what happened four years ago when Bushwasre-elected," said Gooding. "Ibelieve we have the opportunity with Biden and Obama to have a change."



sexual, (and I'd be happy to) - difference of opinion on religious scripture should not prevent all of us from making every effort to positively impact the lives of those who are positive – no matter their sexual orientation.

Do you know that some people with HIV hide their affliction from their friends and family, ignore treatment options, and consequently potentially shorten their mental and physical lifespan by years? Do you know that many of those individuals are black?

As Phil Wilson, the CEO and founder of Black AIDS Institute recently said. "AIDS in America continues to be a black disease as manifested by the numbers." Well, what are the numbers? According to the CDC, African-Americans accounted for 45 percent of the new HIV infections in 2006. Yet, we are only 12 percent of the population. Among blacks, black women are contracting the disease at alarming rates!

A number of issues are said to be the cause for high rates of infection among blacks - poverty, stigma, limited access healthcare, drug abuse, etc. Well, thanks to Jack Ford in respect to healthcare and drug abuse, he's help to create CareNet and SASI to deal with those. Contact CareNet if you're positive and do not have health insurance. See if they can help. If you're a drug user, I'd ask that you do the same with SASI and other organizations like it in Toledo.

And if you're a concerned citizen willing to help those afflicted, I beg of you to contact those organizations and others like it to see how you can.

Literally – our community depends on it. With black gay men ages 13 to 29 being twice as likely to

get infected as white and young Hispanic men – if you believe in that 'the youth are our future,' mantra – I ask you to ask yourself, what actions of yours help to make that belief a reality?

With black women being almost 15 times as likely than white women and four times more likely than Hispanic women to contract HIV and/or AIDS, I ask again, where do our beliefs meet our actions?

This is not just political. This is serious. With available mental and physical treatment, many with HIV and/or AIDS can live 'normal' (I hate that word) and productive life spans. However, without, many will not. And, you play a role in that. Your church plays a role. The Urban League and the NAACP play a role (whether they realize it or not). Black fraternity and sorority organizations play a role. Your small book club plays a role. Everyone does.

Now, I understand that a murder in the black community, for example, (especially by a white person, presumably) may attract our attention and touch our sensitivities. But, if these numbers as it relates to HIV and/or AIDS don't shake your faith, rattle your conscience, give you goosebumps, or at least make you think - I'll ask another question - would you pinch yourself? Because, you must not be awake nor paying atten-

Why is this political? Well, for starters – we need the votes of many HIV afficted individuals to sustain a democratically-based country. We also need policies – in government, church bureaucracy, and groups' organizational structures – to change in

order to make it easier for persons with HIV and/or AIDS to receive the attention they deserve. It's also political because we can do something about it through collaborative social action.

Finally, this treatise is a plea for every human being - African-Americans, especially - whether individually and/or within our respective groups to make the issue of HIV and/or AIDS a major concern about which we devote serious time, energy, talent and other resources. I've argued that our community's livelihood is at stake if we choose to turn a blind eye. I've gladly called out those who choose to support stigma and ignorance over and beyond truth and knowledge - whether it's behind a pulpit or at the family dinner table.

But, of all of this, I ask that you remember that we are all human. I hope we will cling to the commonality we share as humans whether male or female. rich or poor, black or white, bi, gay, straight, transgender, or some other label - as we work together to reverse these devastating CDC numbers, particularly as it relates to blacks and the issue of HIV and/ or AIDS.

If we don't – if you don't – actively and willingly work to improve the quality of life of a fellow human being in need of help – what are we doing?

Dozens Participate in HIV/AIDS Health and Fitness **Walk**

After publicly declaring herself HIV positive several weeks ago, Donna Hamilton has been on a non-stop campaign to educate the masses about the increased rate of HIV/AIDS infection in the African American community.

So it's not surprising then that on Wednesday, Sept. 24, Females Unveiling the Secret, a not-for-profit organization founded by Hamilton and several other women, held a Health and Fitness Walk at Walbridge Park, to shed light on the disproportionate rate of HIV/AIDS among African-American women.

According to the Center for Disease Control and Prevention, in 2004, HIV infection was the leading cause of death for African-American women aged 25-34 years, the third leading cause of death for African-American women aged 35-44 years, and the fourth leading cause of death for African-American women aged 45-54 years.

During that same year, HIV infection was the fifth leading cause of death for all women aged 35-44 years.



and sixth leading cause of death among all women aged 25-34 years.

In 2005, of the nearly 127,000 women living with HIV/AIDS in the United States, African-American women comprised 64 percent of these cases, while

their white and Hispanic counterparts comprised 19 percent, and 15 percent, respectively.

Most of these women reportedly contracted HIV/ AIDS through high-risk behaviors such as unprotected sex with men who have multiple partners, sex with men who sleep with men and injection drug use.

Although these statistics are not particularly surprising to Hamilton, considering what she calls a dearth of information about HIV/AIDS in the African-American community, she says women who participate in such high-risk behavior do so because they are looking for love in the wrong places.

"Everything else takes a backseat for that man, because [we are thinking] I want that man," Hamilton said.

Hamilton urges women to protect themselves by treating every potential partner as though they are HIV positive, and insist on using a condom.

Otherwise, "you have made the ultimate sacrifice when you lay down with that man without knowing his status, and your own," Hamilton said

Females Unveiling the Secret will be supporting a HIV/AIDS testing event held on Saturday, October 11, from 9 a.m. to 1 p.m. at Planned Parenthood, located at 1301 Jefferson Ave.

Every day when you get up, your hips creak. Your spine groans. Your fingers clatter like piano keys in a Bugs Bunny cartoon. As you make your way to the kitchen for a cup of sustenance, your body protesting the whole way, you wonder what's next, according to author Diahann Carroll's new autobiography, The Legs Are the Last to Go. The memories, as you'll read, stick around, too.

Carol Diann Johnson was born in Harlem in 1935 to parents who seemed ill-prepared for achild. Still, little Carol was protected, coddled and encouraged to showcase her burgeoning singing and dancing skills as she eagerly mimicked her favorite big-screen glamour girls. Carol's mother, her biggest fan, demanded perfection and a ladylike demeanor from the young star.

Inspiredby Lena Horne and other actresses from Hollywood's golden years, Carol went to college to study music and arts. She adopted the name Diahann Carroll and appreciative audiences. She was photographed for magazines. She appeared on Arthur Godfrey's Talent Scouts TV show and was invited back several times.

Before long, Diahann Carroll was in high demand on stage and screen.

But while Carroll's career was blazing, her life was in ashes. Her first marriage was broken because of an ill-fated affair with another actor, despite the fact that Carroll had a new baby and a husband who still loved her. Her second marriage was a quick mistake. Her third marriage didn't last long either, nor did other love matches with men who were soul mates and some who were soul hates.

Incredibly, although her personal life was filled with drama, Carroll's career continued on an upward trend. Every time she began to believe that herperforming days were over, another opportunity came along. Even now, at age 70-something, Diahann Carroll stillperforms for live audiences.

Feisty. That's the best word I can find for *The Legs Are the*

Last to Go but I think I would have liked it more if it had less chest-thumping in it.

Author Diahann Carroll gives readers pages and pages of delightful gossip on stars fromdecades ago and stars who grace the tabloids today. Even younger readers will be enthralled by tales of dining on the Onassis yacht, standing up to racism in Hollywood and blazing trails on-stage.

The distraction comes when Carroll waxes diva-like. She writes about conflict with other stars and how she confronted directors and producers when things didn't go her way. She repeatedly talks about "couture," make-up, and luxury cars, saying that she can't live without them. Her blithely nearblameless attitude when writing about family problems made me cringe.

If you can ignore the braggadocio and focus on the fun in this book, it's a pretty good bio from someone who's walked an interesting path and optimistically looks toward the future. If you can't bear another Look-At-Me bio, though, The Legs Are the Last to Go is a book to kick to the curb.



let the people know his accomplishments as mayor.

One of the more memorable functions attended by McCoy was the African American Committee 2000 and Beyond Soulfare celebrating the success of the Civil Rights Movement held at Buell Theatre. The cochairmen for the invent included Congresswoman Maxine Waters (Dem-CA), Tavis Smiley, Jackie Jackson and Daniel Halpern. Danny Glover was the master of ceremonies and the special live concert guest was Maze featuring Frankie

McCoy spoke of Michelle Obama as a very gracious, compassionate, and articulate woman oozing with love for her husband.

The strangest thing McCoy experienced at the convention was seeing the people at the Mile High Center. McCoy states when she



got there people were snaked around two levels of the building. This reminded her of the images of South Africa where the people are forming a trail one down and another upper.

McCoy spotted actor/director Spike Lee and saw a lot of demonstrations and police looking evil. Her personal escort, Amanda, assured her that she was there to assist her in whatever she needed during her stay in Denver. Amanda's attention became even more special when she realized she knew McCoy's daughter Erin.

The energy of the young people to be boisterous, chanting, dancing, and shouting warmed her heart at the convention. Her daughter Kelly flew in to be with her and this was a once in a life time experience she would never forget.

The crowd was signaled to hold up signs that said "Strong Middle Class," "Change," "Unity" on one side and "Obama" on the other, "Common Values Common Purpose", "New Energy for America" as speakers came to the podium in support of Senator Obama.

Then came the night of all the nights at the convention for McCoy. She was seeing, hearing, touching and shouting as Senator Barack Obam was nominated as the candidate for the presidency of The United States.

People were crying, hugging, and slapping hands, as Obama strolled out to the platform. Banners and signs waving like crazy as the crowd exploded into a thunderous applause. This was the most exciting time for McCoy.

The conference is cosponsored by the Graduate Program in Policy History of Bowling Green State University.

The significance of 1808 might be found in the life of a slave in the United States. Barbary was born in 1787 in Africa and sold into slavery in 1800 in North Carolina to the Harrison family (of Founders and Presidents fame). In 1808, Barbary was enslaved, black and 21

years old. Conference speakers, an international and interdisciplinary group of scholars, will explore the question of how to keep slave stories such as Barbary's alive.

The conference will include discussion of other developments that testify to the significance of 1808. Those developments can be found in both large and small events throughout the 19^{th} , 20^{th} , and 21^{st} centuries: in the founding of Liberia in 1847 and its subsequent history; in the

bloody Civil War in the United States; in Reconstruction, and in Jim Crow: in 1908, the year of birth for the late Justice Thurgood Marshall, the first African-American to sit on the U.S. Supreme Court; in the civil rights movements in the 20th century, and in the 1968 assassination of the Reverend Martin Luther King,

The legacy of 1808 can also be found in quiet moments, such as one captured by a 1948 picture of Ada Sipuel, an African-American woman sitting in a Norman, Oklahoma courtroom, dreaming of becoming a lawyer.

"Our goal is to honor the memory of people and events in this important year for all Americans and for the world," said Benjamin G. Davis, associate professor of law at The University of Toledo College of Law. "I was dismayed that no other law school in the United States had developed a program to mark this anniversary.

In working with my colleagues on this project, I have found increasingly just how special the role of Toledo and its environs has been in so many aspects of the issues of slavery and its aftermath - for example, in the Underground Railroad up to Buxton, Canada and in the coauthoring of the $13^{\,th}$ Amendment by Toledo Congressman James M. Ashley."
