Black and In the Red

"Ihave mixed feelings," replied Keith Foster, director of Enforcement for Fair Housing Opportunities of Northwest Ohio concerning President Obama's challenge to banks to make loans available to small businesses and last week's approval of legislation to tighten federal regulation of banks and Wall Street.

"Without strong enforcement and more authority the legislation is not likely to have much effect. The past eight years, unlike those prior, were characterized by a White House administration that was indifferent to enforcement, so it was non-existent," Foster adds.

"Lenders," according to Fair Housing CEO Kathy Broka, "while taking deposits from African Americans, closed branches in inner-city neighborhoods and made very few

loans. The sub-prime lenders with their toxic loans and pay day lenders with their oppressive interest rates rushed in to fill the void."

Broka's insights appear to be confirmed by a Federal Deposit Insurance Corporation (FDIC) study released in December 2009. The report indicates that nearly a quarter of all black households (compared to only three percent of white households) do not have access to federally-insured bank accounts that provide them with the opportunity to conduct basic financial transactions, save for emergencies and long-term security, and access affordable credit. Overall, almost 54 percent of black, disproportionately-poor households, are either unbanked or underbanked and pay more for basic transactions and credit services, are more vulnerable to loss or theft and struggle to build credit histories and financial security.

"It's too expensive to be poor and African-American," states Broka. "You pay higher interest for the loan. The higher payments cause you to be late, hurting your credit score. Your insurance costs are higher. If you need to make emergency repairs the loan shark-like payday loans can cost as much as \$75 for two days on a \$500 loan. And you can almost pass by 16 payday lenders or make four bus transfers before you finally get to a bank."

"If you need a car, you can get one – but only at a buy here/pay here lot at 24 percent interest. And when it breaks down, you've got to go right back to the payday lender because when the banks won't loan the money others come in with their outrageous fees."

The lack of access to mainstream financial products such as bank accounts and lowcost loans often perpetuates a cycle of poverty from which the mostly-black poor cannot escape. Yet efforts are being made locally to serve the un/under-banked community.

Linda Ewing, vice president for Community Affairs at Fifth/Third Bank, admits that making commercial loans has been "a struggle" that could possibly be alleviated as businesses seek ways to partner, collaborate and otherwise build capacity.

"However," she states, "We are working hard to address the problem and to meet the needs of the community. Although we have more requests than available dollars, we try to respond to as many requests as possible. We support organizations such as the African American Bureau of Commerce, the Hispanic Chamber, the Toledo Urban Federal Credit Union and many others."

In response to the lack of community lending products and services available to the underserved, Ewing responds, "We are coming out with our Bank-On program shortly. We have also hired a Community Reinvestment Act (CRA) loan originator that will come aboard in January and we will have a reception to announce where we're going in 2010 – and what grants, products and services geared toward the underserved and Low-Moderate Income community we are offering."

A large proportion of the un- and under-banked are those like Nawja Pitts, a young single mother, who previously had an account. "I used to have an account. The last time a year ago, but you know, different things happened," she says.

Foster and Broka point out "Once individuals get in the CHEX system for bouncing a check, they cannot open another account until the old one is paid. Often there are astronomical fees attached which makes repaying overdrafts prohibitive."

Ewing emphasizes that educational workshops on financial literacy and skills will be required as well as services offered that include building wealth. "In the past", she (Continued on Page 3)

With the net worth of the average black family at one tenth the level of a typical white family and with almost 30 percent of black families with zero or negative net worth, Ewing's prerequisites are not only telling and timely but also instructive.

As Broka and Foster of Fair Housing and others such as Thomas Shapiro, Ph.D., author of The Hidden Cost of

Being African American have noted, the overriding civil rights agenda of the 21st Century may be the issue of economic inclusion and closing

of the racial wealth gap. "There is a growing Asset Development Movement that include matched dollar savings programs based around the goal of structuring ways and incentives for asset-poor families, primarily African-Americans, to begin to accumulate assets for themselves. not just so their pocketbooks are larger, but rather as a tool

to launch their own social mobility in a way that will make them much more selfreliant and independent."

Therefore, in order to escape the cycle of economic oppression that threatens the health and stability of the community, we must not only advocate for economic inclusion, but we must also be determined to learn the money management and wealth building principles necessary to bring us out of financial bondage.

Mayor-Elect Mike Bell Starts to Put His New Team in Place

Mayor-elect Mike Bell sped up the process of putting his new administration in order over the last week naming a complete transition team, appointing three cabinet level officials, announcing a Citizens Special Investigative task force and holding his first transition team meeting.

Several weeks ago, Bell had named a three-person transition team that had started meeting weekly in order to recommend people for the larger 31-person team that Bell announced on Tuesday, December 1. Both teams will be reporting to Steve Herwat, a former city planning director who was himself appointed deputy mayor for operations for the new administration.

The 31-member transition team includes: Jesus Angel, El Camino Restaurant; Marianne Ballas, Ballas Buick/GMC; Aaron Baker, The University of Toledo: Phil Barbosa; Rev. Michael Billian, Toledo Catholic Diocese; Bruce Baumhower, United Auto Workers Local 12: Bob Bernius, Northwest Ohio District Council of Carpenters; Crystal Ellis, former

heels of the formation of the transition team was the announcement of appointments to the three cabinet-level positions in the Bell administration.

Dean Monske, a former head of the City of Oregon's Economic Development Foundation, was named deputy mayor for external affairs - the "business advocate" Bell spoke of throughout his campaign.

Herwat, as deputy mayor for operations, will manage day-to-day operations with the exception of development, police and fire.

Shirley Green, a retired police lieutenant, was named safety director and, in that position, will report directly to the mayor.

Green, who retired from TPD in 2003 after 27 years on the force, is a graduate of Notre Dame Academy who earned her bachelor's degree in history from UT as she was winding down her police career. She subsequently earned a master's, also in history, and is currently working on her doctorate in Early American history while also teaching part-time at Bowling Green State University

She will continue to pursue her doctorate, for which she has completed the course work and needs only to finish her dissertation. Her father, Marshall Swan, is a retired Toledo homicide investiga-

Green has made some history herself on the police force. When she was named watch commander in 1995, she was the first black woman to hold that position.

Part of her interest in American history is attributable to the fact that she can trace her own family background to pre-Revolutionary days.

"Among my mother's ancestors were the two Frank brothers who served in the all-black First Rhode Island Regiment," said Green back in 2002 during an interview with The Truth. "However, one brother then deserted and fought on the side of the British. After the war, he along with many of the Loyalists, boarded ship on Long Island and eventually found their way to Annapolis Royal in Nova Scotia.3

As to her impending duties as safety director, Green (Continued on Page 5)



Josh Project Holds Second Annual Soulfood Extravaganza

emphasized that she will be particularly concerned with not only maintaining safety but also in ensuring that the police and fire department members are providing services "in a professional and timely manner."

"She is an extremely bright person, " said Bell of his appointee. "Sometimes someone coming in after being out [of government] for a while can see things with a clearer eye."

Bell noted that he wanted a full-time safety director because "we haven't given enough attention to safety." Shortly after the an-

nouncement of the cabinetlevel positions, Bell named his financial Citizens Special Investigative (CSI) task force, another one of his key campaign promises. The announcement coincided with new budget estimates from the city that could see a \$40 million deficit in 2010 - \$10 million more than projected in November

Bell's 11-member CSI task force has been charged with conducting a 45-day study of the City's finances and generating the data to give the mayor, City Council, administrators and employees "the ability to work out solid cost-cutting solutions in real time and to operate at a new level of trust," according to the statement released by Bell's spokesman.

The CSI has been comprised of senior-level leaders from accounting, banking, business and labor. The members are: John Alexander, administrator, City of Perrysburg: Deborah Barnett, Huntington Bank; Brandon Cohen, UT College of Business Administration; Don Czerniak, AFSCME Local 7; Dan Frick, retired managing partner of Ernst & Young; Roosevelt Gant, R Gant LLC; Rick Gray, Key Bank; Jim Martin, Firefighters Local 92; George Sarantou, finance committee chairman, Toledo City Council; Dan Saunders, retired City of Toledo finance director and Dan Wagner, Toledo Police Patrolmen's Association.

"These professionals have committed to an intense job, but I'm hopeful that the work they do will set the foundation for long-term financial planning for our City," said Bell.

You Mean Copenhagen Can Impact Toledo?

By now everyone knows except perhaps those who deliberately run from news reports - that environment leaders from over 190 countries are participating in the United Nations climate conference in Copenhagen, Denmark to hammer out a deal to save the planet.

The meetings will culminate on December 18, with more than 100 heads of state. including President Obama. seeking a framework that will determine who will do what. how much and when to slow climate change. Toledo may be over 4,100 miles from Copenhagen, but the goingson there can wind up impacting our local economy and our immediate natural environment.

Basically, representatives of governments are haggling over how quickly they will reduce their greenhouse gas emissions and who will pay for the reductions of those who can't afford the newer. carbon-free or at least carbon-reducing technologies. Since the United States, the European Union, Japan and Russia (the Big 4) are responsible for some 70 percent of the carbon dioxide (CO2) build-up in the world's atmosphere over the past century, many say that the Big 4 collectively has an ecological debt to pay to those who didn't turn up the world's thermostat.

Rather than providing reparations to those who didn't introduce climate change, destabilize ecological systems, threaten the biological diversity of species and cause sea levels to rise by heating up the world, the sentiment is more that the Big 4 should be forced to undergo the sharpest and quickest CO2 reductions and they should underwrite the technology costs associated with a transformation to green technology for poorer coun-

After all, the Big 4 industrialized economic entities, in varying degrees and varying durations, expropriated the wealth of poorer peoples with greenhouse gas-inducing technologies.

The Big 4 will insist that it's not that simple. After all, they argue that the economies of China, India and Brazil in the future will certainly dwarf some of today's industrial giants. As a result, these large, emerging economic powerhouses should not only agree to big CO, reduction but they must also pay for their own transition to green technologies.

That is one issue. Another issue concerns the other category of poorer nations that have neither benefited much from the technologies that have contributed to CO, nor can they afford the technological transformation. These are Third World countries such as Cambodia, Nicaragua, and Malawi. There are well over 130 nations in this category

So the big items of the Copenhagen meetings are these: (1) how quickly will the CO2 draw-downs be for the bigrich nations; (2) how much of a CO2 draw-down will the still underdeveloped, yet big, rapidly economically advancing nations agree to (since they, understandably, have a chip on their shoulders about being asked to clean up after someone else's mess) and (3) how much support, through new technology assistance, will the Big 4 pay on their ecological debt to the 130 or so poor nations.

More aggressive outcomes in these three areas translate into faster transitions out of fossil fuels and into renewable energy. In order for the United States to meet its new CO, reduction targets, as agreed to by 2020 and each successive decade up to 2050, renewable energy tech firms such as First Solar in the Toledo area will have to expand their production. And because other rich and emerging economic powers will also be racing to lower their carbon footprint due to the global climate framework through, in part, renewable energy, companies such as First Solar could further expect expanding markets.

Even payment by America on its share of the ecological debt to the 130 poorest na-

tions will also result in new business for local and other US renewable energy companies. With nearly all forms of foreign aid, it isn't as though the government in Washington simply cuts a check and mails it off to a poor country or executes a wire transfer of funds.

Instead, with the exception of just one or two countries, the US government provides support by contracting with American institutions to provide some service or technology transfer to a poor country. So the greater the ecological debt payment that America makes

Again the national spotlight is shinning on northwest Ohio because of the high incidence of foreclosures of homes in our region. Recently, the Reverend Jesse Jackson visited Toledo and gave a speech to address the issue, pointed out some of the causes and affects and provided some possible solutions to help citizens who are struggling to keep their homes and to hold their families together. Using these strategies is a smart way to weather the financial storm and perhaps come out on the other side without too much damage. Yet, pride comes before the fall. Others have elected to just pretend as if

nothing is wrong and everything is under control until it's too late.

Some have just walked away from their property without so much as a word to their lenders, thereby leaving the property vacant and causing blight in many neighborhoods that were historically stable. Some, frustrated with the lack of cooperation from the bank and limited help from the government, have simply given up. This is absolutely the wrong decision. I say fight for your home. The result of that meeting was a Men's Day luncheon, an opportunity for students to invite the men in their lives to sit with them during their lunch, and share a piece of their day's experience.

The outpouring of support was astounding. Jackie Tyre happened to be a substitute teacher at Independence on Men's Day.

"It was beautiful! To

walk into that lunchroom on that day and see all those men sitting with the students was a beautiful thing" she said. "The looks on the faces of those students told the whole story, they were smiling from ear to ear, full of excitement and pride. It was just wonderful!"

Lowe stated there are a list of positive outcomes that go along with a program like this: "There is a connection that is created between the parent and the people at the school. The students see a different side of their teachers and administrators when they see them laughing and talking with their parents. It is a visual reminder for the students of how important their fathers or mentors believe education is for their quality of life. And, of course, it is proof positive that they are valued by another adult. Those are all very positive statements to put in a child's arsenal."

Nearly 75 men participated in the Men's Day luncheon; some trickled over to days after Thanksgiving due to work schedules and other life issues. But they had made a commitment to the activity, and they followed through.

"There were some fathers who cannot be here because of circumstances that are beyond their control, so some of the men were uncles, cousins, mentors, deacons, but they came and made a difference in the life of a student at this school, it was a great event." Lowe said.

"There was one little guy standing outside the lunch line crying, so I walked over and ask him what was wrong," said Tyre who had lunch duty that day. "He said his father was supposed to come, but didn't. I told him that maybe something important came up, and his father couldn't make it. 'No,' stated the boy emphatically. 'He's probably just at home playing that game!' It's obvious we still have some work to do; but I have to say it's a real positive start."

"We are planning to do another Men's Day in the spring, in fact, we might do a Women's Day. Hopefully, the more comfortable parents are in the school, the more they may think about becoming an active part of what we're trying to accomplish here with our young kids," said Lowe.

Lowe went on to say this was a first step in creating an environment for parents to want to become part of the PTA. "Our kids need us. They need us to want to be here for them so they don't feel alone, and so they know we are expecting them to be successful, and that their success means positive things will happen for them, their families and our community."

Emmanuel Curtis heads an effort in the middle and high schools called "Positive Lifestyles" that brings adults into the schools from several different career strains - factories, small business owners, large corporations and independent contractors, even city and county government officials for direct access to the students to talk about their life choices and the benefits and pitfalls of their jobs.

The program has been going strong for a number of years under his supervision, and continues to have a solid impact on students in the Lima City School system. Curtis continuously calls for additional involvement from the adult community in and near Lima. Each month there are adults in the schools, talking with students and encouraging them to make good choices during their educational careers so they can have a greater range of possibilities after their college or trade school experience.

"It all comes down to paying it forward," says Lowe. "We've got to make solid investments in these kids, and that has to include the parents. Sometimes the parents need just as much encouragement as the kids do, they feel they are not on top of their game, so how do we expect them to guide their kids? We've got to make sure parents and students know we support them. We believe in them. We're counting on them, and we know they can pull it off."
