# House Bill 136 Will Cause Great Harm to Our Public Schools

A strong public education has long been a cornerstone of this nation's success. Access to free primary and secondary education has been crucial to the United States position as a world leader. Education is the foundation

Education is the foundation of the middle class and the best ticket to advancement and prosperity for all citizens. Having educated, informed and en-

gaged citizens is critical to the survival of our democracy. During these difficult economic times it is even more important that we protect and improve our public education system, because having the best schools is vital to growing our economy. A comprehensive education system prepares our children for success in the 21st Century and strengthens Ohio's long-term economic vitality. A lesser public education system will weaken our workforce and make Ohio less attractive to businesses, leading to fewer jobs.

As many local communities face difficult choices and cuts to services such as education, it is critical that we support our educators so they have the tools and resources necessary to prepare our children for a successful future.

House Bill 136, now being considered in the Ohio House, would divert precious resources away from public education and put it toward private and charter schools. This could cost public school districts, already suffering from massive budget cuts, to lose millions more in funding. These are dollars that you as a voter designated to public schools through local property-tax levies.

This raises serious questions about the legislature's right to take local property-tax dollars and divert them to a cause for which they were not originally intended. This takes control away from you, the taxpayer, and contributes to the continued erosion of local control.

We must instead insure that public education is fully funded in Ohio, so districts can count on a stable revenue source. This is the best possible way to provide the best possible education for all of Ohio's children.

During the drama-rama currently taking place in our local and national history, it is imperative that vulnerable populations. including the poor and our children, overcome the evils that attempt to extinguish their potential and the world's future especially the evil of poverty and its derivatives. So far, this population has been left out of the conversation while their condition worsens despite the material benefits received by those entrusted to provide positive change for

The poverty of earning a college degree, having children, opening a child care center, and taking home \$300 a week or month if you're lucky.

The poverty of loneliness and isolation and alienation—having no one to call or visit, tell you where to get help, assist you in getting it, or care if you're living or dead.

The poverty of having too much and sharing too little and having the bur-

den of nothing to carry. The poverty of convenient blindness and deafness and indifference to others, of emptiness and enslavement to things, drugs, power, violence and fleeting fame.

The poverty of low aim and paltry purpose, weak will and tiny vision, big meetings and small action, loud talk and sullen grudging service.

The poverty of believing in nothing, standing for nothing, sharing nothing, sacrificing nothing, struggling for nothing.

The poverty of pride and ingratitude for God's gifts of life and children and family and freedom and country and not wanting for others what you want for yourself.

The poverty of greed for more and more and more, ignoring, blaming and exploiting the needy, and taking from the weak to please the strong.

The poverty of addiction to drugs, to drink, to work, to self, to the status quo and to injustice.

The poverty of fear that keeps you from doing the thing you think is right. The poverty of despair and cynicism.

God help us end poverty in our time in all its faces and places, young and old, rural, urban, suburban and small town too, and in every color of humans You have made everywhere.

God help us to end poverty in our time in all its guises—inside and out physical and spiritual, so that all our and Your children may live the lives that You intend.

Can you imagine the thousands and thousands of dollars (spent by each celebrating church) that would be saved and could be diverted to really needy local causes and missionary endeavors if the black pastors would simply be gracious and say, "Thanks but no thanks. If you want to really thank me, be obedient to the Word of God and also bless others."

**NUMBER THREE:** Can we get a thorough accounting by an outside CPA entity to examine the financial records of the local NAACP branch?

### Letter: Thoughts on the Hope Article by Rev. D.L. Perryman

Concerns about your November 30<sup>th</sup> article in <u>The Truth.</u> "The Substance of Hope." You posed the question, "What is it about our system, which enables the violence by black males upon black males to thrive and survive?"

My initial reaction was, What "system?" In responding to your own question you wrote," To put it succinctly, it's drugs."

I'd like to address "system." My conviction is the system most relevant to the lives of our black males, as well as any and all youth, is their home system. While reading your article, I immediately wrote on the page, "the absence of teaching, structure and accountability."

Certainly, no reasonably aware individual would argue that has not been, nor does there continue to be, racial and other social inequities in America. However, neither can we negate the value of family relative to a healthy sense of self-worth and social responsibility. I strongly reject the suggestion that crime is fostered by one's "economic opportunity." Historically, most black people have lived in low socio-economic family circumstances. That, in and of itself, does not justify black-on-black crime.

I further contend that the single most significant factor allowing for widespread negative behavior among our young men is the absence of father/role-models in their lives. Your article did note that the education system needs to "counter...the black child's home life..." Who is responsible for the black child's home life?

I do commend black men who demonstrate their desire to "take care of their families and children". However, I reject the notion that "public policy" is the cause for so many of them not doing so. What percentage of American black children live in single-parent households headed by females?

Goal-setting for children should not be relegated to school teacher or other social organizations. Prior to starting school, children should have been instilled with a healthy sense of self and high "expectations" from home. All too often we tax our schools with providing direction and nurturing that are the responsibility of parents. Children must be buoyed by "you can do it" from home.

Unfortunately, positive achievements of our young men are "overshadowed." However, we are responsible to "toot our own horns." We need to "accentuate the positive" and "go tell it on the mountain."

# Kent Branch Library @CCESS Center and Cybermobile Open for Business

The Kent Branch Library @CCESS Center and cybernobile made an official debut on Monday, December 5 at an Open House and Ribbon-Cutting Dedication completing a year-long renovation project funded by a \$2.2 million federal stimulus grant, community partner support and Library funding.

The Toledo-Lucas County Public Library, along with 56 local partners, was awarded a Broadband Technology Opportunities Program (BTOP) grant totaling more than \$2 million to support a public computer center at Kent Branch Library and cybermobile that are now providing free education and training classes for computer literacy, health awareness and job skills.

What is BTOP? - It is one of the U.S. Department of Commerce's federal stimulus programs that assists in developing public computer centers in libraries and other community centers under the Broadband Technology Opportunities Program. The money was awarded on a competitive basis to promote public use of computers and to offer skills necessary to spur job creation and stimulate long-term economic growth and opportunity.

BTOP targets vulnerable populations such as the under-served, unemployed, low income, minority, children, seniors, hearing and visually impaired, physically challenged and socially and economically disadvantaged

On opening day, a brief private Ribbon-Cutting Dedication got underway at 8 a.m. featuring United States Congresswoman Marcy Kaptur, who initially encouraged the Library to apply for the BTOP grant. Congresswoman Kaptur and Clyde Scoles, Library Director, addressed some 70 representatives from the 56 grant community partners and Library staff, thanking all for their dedication and commitment during a renovation process

year. The Buehrer Group was the architectural firm and The Spieker Company served as the general contractor for the Kent Branch Library @CCESS Center project.

"This is a win-win situation for the Toledo-Lucas County Public Library, local partners and the community and will improve the quality of life for residents in Lucas County by spurring job creation and stimulating longterm economic growth and





opportunity," Scoles told onlookers. Kaptur added that the @CCESS Center and cybermobile, which is scheduled to take to the road on January 3, 2012, will "unlock" the keys to a world of opportunity for so many of the Library's patrons.

In addition to Kaptur and Scoles, many were responsible for applying for the grant and seeing the project through fruition, including Margaret Danziger, Library Deputy Director; Jeff Wale, Library Information Technology Manager; Charlie Oswanski, Facilities and Operations Superintendent; Faith Hairston, Kent @CCESS Center Manager; Pat Nigro, @CCESS Center cybermobile; the Library Marketing team, 56 community partners, Library staff, and so many more!

The changes made to Kent are dramatic. The Library @CCESS Center had 30 computers before the renovation, and now has some 129 high-speed Internet public and staff computers; a



computer training room; an expansion to the building of more than 900 square-feet; colorful paint added to the walls; computers specifically designed for those with vision and hearing impairments and p On December 5, the Kent @CCESS Center officially opened to the public at 9 a.m. and closed at 8:30 p.m. seeing nearly 1,000 loyal patrons and neighborhood residents on Opening Day. So many patrons said they waited patiently for the opening of their neighborhood branch which was well worth

the wait.

Hairston has remained as the manager of Kent and shared that she is elated at all of the positive changes and improvements to the location. The Kent Branch Library @CCESS Center is located at 3101 Collingwood Blvd. Mobile Technology @CCESS Center

Two adaptive workstations will have enhanced audio and larger keyboards, along with SARA Scanning, ZoomText, and 2010 Microsoft Office Suite• Programs will be offered aboard to include Basic Computer Use, Basic Internet, Intermediate Internet, Email, and Job Resources• Wheel-chair accessibility. The mobile classroom will expand Library services to seniors, underserved, low-to-moderate income, and minorities.

Mom and Dad were heading out, leaving you in the care of someone responsible and older who let you eat snacks you usually couldn't have, watch TV you usually weren't allowed to see, and stay up way past your bedtime. It was almost like having a mini-vacation.

Butnow that you're getting bigger, you wish you could babysit yourself because you're certainly no baby. But in the new book *Latasha and the Little Red Tornado* by Michael Scotto, illustrated by Evette Gabriel, a young girl learns that responsi-

s bility comes with growing up.

Eight-year-old Latasha Grady hates it when she's sent downstairs.

That's because Mrs. Okocho, who came from Nigeria and lives downstairs, is Latasha's neighbor *and* her landlady *and* her babysitter.

Mrs. O can be grumpy but Latasha likes her, so that's not the problem.

The problem is that Latasha's not a baby anymore and she doesn't think she needs babysitting. She really wishes Mama would lether stay upstairs by herself while Mama goes out to look for a job. Besides, spending time with Mrs. Okocho means that Ella is left all alone in their Pittsburgh apartment. Ella Fitzgerald Grady is Latasha's dog and she's a wild girl. Ella – who was named after the singer – has a lot of energy because she's still a puppy and she likes to zoom all over the apartment. Latasha knows that Mrs. O doesn't like the noise that Ella makes when she gets the zoomies. Mrs. O doesn't like Ella much at all. in fact.

Knowing that, and knowing that the red fluffball has a mind of her own, Latasha decides to teach Ella to be the best dog in the world. She has to do it fast, though, because Mama finally landed a job! That means Latasha has to spend after-schools with Mrs. O, but at least she finally has permission to take Ella for walks at a



nearby park first... But Ella just can't let go of the zoomies and when the worst thing in the world happens, Latasha takes all the blame. Will everybody be able to forgive her? Can Latasha ever forgive herself?

Looking for a good winter-break book for a kid who's growing up too fast? Latasha and the Little Red Tornado is perfect, especially if that kid is a doglover.

With realistic situations and language that's not fakey, author Michael Scotto brings young readers a friendly, smart little heroine who's surrounded by believable, likeable characters. I really enjoyed this book because it's got a little drama, some excitement, and – spoiler alert here! – some sadness that ends up not-so-sad.

You'll also want to know that, though this book is meant for older gradeschoolers, some of its words are pretty big for that age group and independent readers may be challenged. Still, with a little help and such a wonderful main character, *Latasha and the Little Red Tornado* will keep your 7to-11-year-old happily sitting for a good long time.

For the month of December, the Toledo-Lucas County Public Library recommends the book *Phyllis Wheatly: Biography of a Genius in Bondage* by Vincent Carretta (Athens: University of Georgia Press, 2011)

With poems on Various Subjects, Religious and Moral (1773), **Phillis Wheatley** (1753?—1784) became the first English-speaking person of African descent to publish a book and only the second woman of any race or background to do so in America.

Written in Boston while she was just a teenager, and when she was still a slave, Wheatley's work was an international sensation. In this new work *Phills Wheatley*, author Carretta offers the first full-length (Continued on Page 13)

President Barack Obama recalled his struggles with student loan debt as he unveiled a plan Wednesday that could give millions of young people some relief on their payments. Speaking at the University of Colorado Denver. Obama said that he and his wife. Michelle, together owed more than \$120,000 in law school debt that took nearly a decade to pay off. He said that sometimes he'd have to make monthly payments to multiple lenders, and the debt meant they were not only paying for their own degrees but saving for their daughters'college funds simultaneously.

"I've been in your shoes. We did not come from a wealthy family,"Obama said to cheers.Obama said it's never been more important

to get a college education, but it's also never been more expensive. Obama said his plan will help not just individuals but the nation because graduates will have more money to spend on things like buying homes. "Our economy needs it right now and your future could use a boost right now,"Obama said.Obama's plan will accelerate a measure passed by Congress that reduces the maximum required payment on student loans from 15 percent of discretionary income annually to 10 percent. He will put it into effect in 2012, instead of 2014. In addition, the White House says the remaining debt would be forgiven after 20 years, instead of 25. About 1.6 million borrowers could be affected. He will also al-

low borrowers who have a loan from the Federal Family Education Loan Program and a direct loan from the government to consolidate them into one. The consolidated loan would carry an interest rate of up to a half percentage point less than before. This could affect 5.8 million borrowers. Student loans are the number two source of household debt. The president's announcement came on the same day as a new report on tuition costs from the College Board. It showed that average in-state tuition and fees at four-year public colleges rose \$631 this fall, or 8.3 percent, compared with a year ago. Nationally, the cost of a full credit load has passed \$8,000, an alltime high. Student loan debt is a common concern voiced

by Occupy Wall Street protesters. Obama's plan could help him shore up re-election support among young voters an important voting bloc in his 2008 election. But, it might not ease all their fears. Anna Van Pelt, 24, a graduate student in public health at the University of Colorado Denver who attended the speech, estimates she'll graduate with \$40,000 in loans. She called Obama's plan a "really big deal" for her, but said she still worries about how she'll make the payments. "By the time I graduate, my interest rate is going to be astronomical, especially when you don't have a job,"Van Pelt said. "So it's not just paying the loans back. It's paying the loans back without a job."

From 2002 -2004 he served as Academic Dean and Lead Navigation Instructor for Naval Science Institute From 2006 - 2007 he served as Anti-Terrorism/ Force Protect Instructor Training Program Manager for Military Sealift Fleet Support Command. In 2007 he moved to Military Sealift Command Headquarters where he was Curriculum Manager continuing to work

extensively in maritime training

He has eight years active duty experience as both a Surface Warfare Officer and as a Strategic Sealift Officer. He is also a merchant marine officer (Second Mate) with extensive maritime experience. biography of a figure whose origins and later life have remained shadowy despite her iconic status.

A scholar with extensive knowledge of transatlantic literature and history, Carretta uncovers new details about Wheatley's origins, her upbringing and how she gained freedom. Carretta solves the mystery of John Peters, correcting the record of when he and Wheatley married and revealing what became of him after her death.

Assessing Wheatley's entire body of work, Carretta discusses the likely role she played in the production, market-ing, and distribution of her writing. Wheatley developed a remarkable transatlantic network that transcended racial, class, political, religious, and geographical boundaries.

Carretta reconstructs that network and sheds new light on her religious and political identities. In the course of his research he discovered the earliest poem attributable to Wheatley and has included it and other unpublished poems in the biography. Carretta relocates Wheatley from the margins to the center of her 18<sup>th</sup> Century transatlantic world, revealing the fascinating life of a woman who rose from the indignity of enslavement to earn wide recognition, only to die in obscurity a few years later.

# Auditor's Office Offers Access to Information about Unclaimed Funds

The Lucas County Auditor's Office has opened an online site listing unclaimed funds.

"We want to make sure people are aware and that they understandhow they can claim the funds," said Auditor Anita Lopez during a press conference last week announcing the launching of the the site.

According to Lopez, auditor offices throughout Ohio are now required to make citizens aware of the unclaimed county funds. The total amount of such funds being held by Lucas County is \$1,093,587.50 – some of which goes back to 2006.

In fact, Lopez noted that individuals, companies and other entities who can claim funds going back as far as 2006 need to do so as soon as possible, there is a five-year limit on the ability to lay



claim. After December 31, 2011, the 2006 unclaimed funds go into the Lucas County general fund.
