

The Power of Innocent Blood

"The innocent blood of these little girls may well serve as the redemptive force that will bring new light to this dark city."

— Rev. Martin Luther King, Jr. (1963)



At 10:22 a.m., the reverberating roar of a bomb blast sounded throughout the city of Birmingham, Alabama. The explosion blew a seven-foot wide hole through the basement walls of the Sixteenth Street Baptist Church leaving a large crater where the women's lounge had been located. The bomb's violent force blew the face of Jesus out of a stained-glass window.

Five little girls had just finished their Sunday school class on "the love that forgives" and were helping each other get dressed, all in white, to lead the youth day service. Fourteen-year old Addie Mae Collins was tying the sash of young Denise McNair, age 11. Carole Robertson and Cynthia Wesley, both 14, were styling each other's hair.

The girls' blackened young bodies, buried under mounds of rubble and found on top of each other "as if they had hugged each other," were identifiable only by shoes and rings. Sarah, Addie Mae's younger sister, barely escaped the massacre.

However, it was the mixture of grief and anger from the "Birmingham Sunday" tragedy that provided the pivotal turning point in the Civil Rights Movement. It was the slaughter of innocent youth that led to the all-out, nonviolent assault against voter injustice that produced the monumental 1965 Voting Rights Act (recently watered down by the Supreme Court).

Fifty years after the horrifying tragedy of Birmingham Sunday, contemporary government and faith face, what Albert Boutwell, then newly-elected Birmingham mayor and John Cross, the new young pastor of a reluctant Sixteenth Street Baptist Church, faced in 1963.

In 2013, young people continue to be

marginalized by class and color by the callousness of adult indifference about their care, dignity and future. Babies and defenseless young girls (and boys) continue to be slaughtered, not only by pathologically disturbed individuals, but also by killing of their hopes and dreams by the hands of an "uncaring public that does not take its responsibility to young people seriously."

And therein lies our failure, exclaims Yolanda Pierce, PhD. "We are not interested in the clearest possible understanding of the structures, powers, and principalities faced by those in need, in poverty, in despair, on drugs, depressed, lonely or hurting. We seem callously disinterested in the root causes and systematic injustices which create a permanent underclass or render people unable to 'pull themselves up by their bootstraps.'"

As people of faith, Pierce adds, "We are far too ready to prescribe more prayer, more faith, and more sacrifice to those who are suffering. We are far too ready to insist on personal moral failings or to demonize a lack of willpower or lack of motivation to those who live at the bottom rung of society."

In his eulogy for the four girls, Martin Luther King, Jr., in a divine reframing of tragedy into triumph, repeated what Lincoln had done 100 years before at Gettysburg by transforming "gory suffering and dying into redemptive rebirth."

Consequently, the tremendous emotion of that sad day 50 years ago was "not expressed through violence or retaliation" but rather, served as a call to action.

Stewart Burns, PhD, advocates a contemporary call to remembrance and encourages that every college campus, house of worship, American and ally to the voiceless and oppressed hold acts of expression to honor the four innocent girls.

"Half a century after the horror of Bir-

mingham Sunday," he says, "we have an opportunity to commemorate these four lost lives and to (re)commit ourselves to the aims of racial and economic justice for which they died. We know that racial and economic justice are more entwined than ever, the 'malignant kinship' of race and class

We call on all Americans, of all ages, colors, and creeds, to find a fitting way to honor the four girls, on or around Sunday, Sept. 15, 2013, that looks toward how our pressing goals of racial, economic, and environmental justice can be attained. And how, specifically, we can get going, keep going, on this journey NOW in order to effect change in the next 50 years."

Although each college campus, high school, middle or elementary school, neighborhood, or community organization is encouraged to organize its own "forward-looking" commemoration, Houses of worship, in particular, are being asked to ring their bells or chimes FOUR TIMES on Sept. 15 at 10:22 AM, "the moment of the bombing that literally stopped the clock forever in the Birmingham church sanctuary," and for the minister or lay person to call out the names of the four girls, Addie Mae Collins, Carole Robertson, Cynthia Wesley and Denise McNair.

In Toledo, we might also ring bells and call out names such as Keondra Hooks, Paige Hayes, Logan Hayes, Madalyn Hayes, Elaina Steinfurth and the names of the many other innocent young lives lost locally.

marginalized families helping to rectify issues with the educational community. She was one of the founding members of the renowned University of Toledo Annual Conference for Aspiring Minority Youth and Toledo EXCEL. She was



instrumental in the development and implementation of several unique programs for public schools. She was voted Mother of the Year, by the Delta Sigma Theta Sorority, Inc. in 2011.

Like many this year's Honorees, Joseph Sommerville, Ph.D, has not just influenced, but has literally changed lives. Sommerville is a graduate of Morehouse College and



has earned four graduate degrees from the University of Michigan including his doctorate. He is a professor emeritus of The University of Toledo where he served as a full-time professor of Administration and Supervision in the College of Education for 22 years as superannuate professor. After his retirement, he continued his 23 years of service on the Toledo-Lucas County Board of Trustees. Sommerville directed the Administrative Internship program. He taught and published extensively while serving as the graduate student adviser for many administrators and supervisors throughout the Toledo area. He was married to the late Mattie Cunningham Sommerville for 57 years.

Samuel L. Price is a graduate of Scott High School and graduated from the University of Illinois in 1966 earning a Bachelor of Science degree in Education. He was drafted number 14 by the NFL's New York Giants



and number by the Miami Dolphins AFL team in 1966. After football, he became a Campaign Director for the Mayor of Dade County receiving a key to the City of Miami. Price has owned a Burger King franchise, The Big Sam Steak and Onion restaurant, and a dental office and city block with an auto dealership. He is married to Carolyn J. Price.

Myra Waters, Ph.D, was born and raised

in Toledo, Ohio attending both Ella P. Stewart elementary and Libbey High School. She played mostly center position while at Libbey due to her height. She received a basketball scholarship to the University of Maryland at College Park and took her team (The Maryland Terra-

pins) to their first NCAA Women's Final Four. Waters still remain on Maryland's list of the 10 list of "scorers!" As Waters succeeded in basketball, she also succeeded in academics. Waters pursued her edu-

cation ultimately receiving a doctorate in counseling psychology. Presently, she serves as director at the Counseling Center at the University of Baltimore.

Two individuals will be honored posthumously this year. Daniel Mack, born in Yazoo City, Mississippi migrated to Toledo in 1925. Robert Powell, Sr. relocated to Toledo area by way of Drew, Mississippi in 1946. He was proud member of Phillips Temple CME remaining a





faithful member until his passing. Powell, Sr. worked as a Pullman Porter and was an employee of Chevrolet Corporation and Doehler-Jarvis. He dreamed of owning his own




business and in 1966 with just \$275, he purchased wholesale hair products selling them still forty years later, Powell's Beauty and Barber Supplies has remained a family affair with descendents of Robert M. Powell, Sr still serving Toledo's African-American community.

Phoenix Academy Helps Students Find Academic Success



Sherman Alexie's Blasphemy


In his last work, a collection of new and short stories published last year, American Indian author and poet **Sherman Alexie**'s *Blasphemy* demonstrates "his talent on every page" – so says a review in the *Boston Globe*.

Alexie is scheduled to appear in Toledo on Wednesday, September 11 at 7 p.m. as part of the Authors! Authors! series, presented by The Blade and arranged by the Toledo-Lucas County Public Library. He will discuss his career and works at the Stranahan Theater, 4645 Heatherdowns Blvd., and Barnes and Noble Booksellers will be on hand to sell his works to attendees. After Alexie's lecture, he will engage in a brief Q and A, followed by a book signing. Tickets are \$10/\$8 for students and available at all library locations or at the door.

The Globe review goes one to state that Alexie "once again reasserts himself as one the most compelling contemporary practitioners of the short story. In Blasphemy, the author demonstrates his talent on nearly every page. These are deceptively simple, swift-moving stories awash with characters in the thrall of various sins and existential quandaries. Alexie deftly administers near equal doses of pathos and humor, providing such smooth entertainment that some readers may glide over his empathetic treatment of such themes as racism, identity, family, loyalty, and ceremony. . . . Will appeal to fans of Junot Diaz, George Saunders, and readers new to Alexie will find this enriching collection to be the perfect introduction to a formidable literary voice. . . . [Alexie] illuminates the lives of his characters in unique, surprising and, ultimately, hopeful ways."

Alexie is also the author of War Dances. and poems, from Grove Press, and Face, poetry, from Hanging Loose Press. His Reservation Blues. received one of the fifteen 1996 American Awards. His first

young adult novel, *The Absolutely True Diary of a Part-Time Indian*, is a semi-autobiographical partgraphic novel that won the 2007 U.S. National Book Award for Young People's Literature and the Odyssey Award as best 2008 au-



diobook for young people (read by Alexie himself). War Dances won the 2010 PEN/ Faulkner Award for Fiction, and he wrote the film Smoke Signals which won the Sundance Film Festival audience favorite award.



"For Discrimination: Race, Affirmative Action, and the Law" by Randall Kennedy

You were pretty sure the job was yours.

You successfully interviewed, passed a background check, even met the office's other workers. Every-

thing looked positive – until you got a "we're sorry, but" letter. Someone else got hired, and there was a small part of you that wondered if it happened that way, not because of your skills but because of your skin.


Hiring on the basis of race or gender is supposedly illegal... but it happens. And in the new book "For Discrimination" by Randall Kennedy, we read why the author believes that affirmative action is an idea that needs to stay.

It should come as no surprise that discussions of an early form of affirmative action came at the end of the Civil War. It may also come as no surprise that Andrew Johnson opposed a Constitutional amendment on the basis that it gave "the Negro" advantages that had never been given to other groups.

In 1945, New York was the first state to pass a law banning racial discrimination in the workplace. Some twenty years later, the Civil Rights Act made it illegal, nationwide. Still, several powerful people then – some of them black – opposed any law favoring specific races or genders.

"Despite wide-ranging attacks against affirmative action," says Kennedy, "it has, remarkably, continued to survive." That may be, arguably, because it's sometimes "justified as a means" of reparation, diversity and integration, and "countering ongoing racial prejudice."

There are, of course, pros and cons to those arguments – the "single most powerful" one of the former being that racial affirmative action "seeks to rectify, at least partially, injuries that continue to put certain racial minorities at a competitive disadvantage with white peers." Still, some who've benefited also



complain that rectification leads to a "stigma" of having been hired or admitted, not based on qualifications, but because of affirmative action itself.

And what about "reverse discrimination," a scenario that affirmative action opponents purport? Kennedy says that they and the "disappointed white candidate" who feels he's a "victim" should understand that affirmative action addresses "a major so-

cial problem: the continuing trauma of racial division in America."

"Racial affirmative action needs to be better targeted," says Kennedy. But not having it would be "a calamity."

Filled with law terms, legal precedents, and words that made my head swim, "For Discrimination" is very, *very* academic. Author Randall Kennedy is a Professor of Law at Harvard, a graduate of Princeton, and a Rhodes Scholar. It shows, and that makes this book hard to read – not because of what he says, but for how he says it.

And yet, this is an important book. Kennedy, who admits to having benefitted from affirmative action, will force a lot of long-needed conversations with his opinions, conversations for which he includes abundant, solid fodder.

This book is about as far as you can get from a casual read, and should be approached with an open mind, general legal knowledge, and a good dictionary. If you can handle that, then go ahead and make "For Discrimination" yours.
