Power of the Black Vote

It was a glorious sight. Long marginalized and written off as a political force, black voters, organizers and strategists leading the work that doubled and tripled black voter turnout from Milwaukee to Detroit to Philadelphia to Atlanta and across American cities.

Without a doubt, black voters were critical to the election of the Biden/Harris ticket and others. And behind great numbers of black voters stood the dignity, grace, persistence, and power of black women. The nation, Church, community, and family have always seemed to turn to black women when things get hard or out of fix. Kudos to local organizers such as Tina Butts of the Movement and leaders of the Ohio Unity Coalition for their untiring competent leadership.

Yet, a defeated Trump improved his 2016 popular vote by almost 7 million. This large total reveals the vast divide which still exists between urban and rural citizens, college-educated and the less-educated, and the forward-thinking and those who long for a past that is no more.

In 2019, according to Bloomberg News, people of color represented just under 40 percent of the total U.S. population. However, non-Hispanic whites will shift from a majority to a minority population by 2045. This "darkening of America," likely then, lies at the root of the divide as many white Americans fear the potential loss of privileged status that has benefited them since the founding of this nation.

Despite the 2020 election, two separate Americas remain. Systemic racism, wage, health, and wealth disparities persist.

Will the power of the black vote translate into tangible policies or better black life?

Here are a few thoughts on our local election results.

Judge Myron Duhart

Duhart is an esteemed public servant, leader, and role model whose successful campaign vaulted him to the Ohio Sixth District Court of Appeals, a valuable part of the judicial process. Judge Duhart proved his worth in Common Pleas, demonstrating that he was not afraid to make difficult decisions with clear-headed compassion. His presence on the Appeals Court ensures a fair and diverse perspective when those qualities are vital.

Lucas County Sheriff

Voters deemed Sheriff-elect Mike Navarre's experience in law enforce-

ment decisive in selecting him to operate and possibly build a new jail. Navarre has been a police chief and leader on police and criminal justice reform at the state level.

Navarre will need to listen to others who have a voice in Toledo's black community such as Earl Mack, who finished third in the Sheriff race. Mack also has several years of law enforcement experience, a sizable following, and considerable community development experience. Earl Mack is the ideal candidate for a position in Navarre's administration.

Current Toledo Police Department Chief George Kral has been keeping a super low-profile lately. Look for Kral to possibly replace the departing Navarre in the Oregon, Ohio Police Department or soon take a position elsewhere.

Who will replace Kral?

For certain, the 52 homicides to date and continuing violence in Toledo is inexcusable. Derrick Diggs, past TPD, and current Fort Meyers, Florida Police Chief, has run a cutting-edge 21st-century police department for several years. Diggs turned around a failed police department that lacked discipline and was rife with corruption, favoritism and racial problems. Under Diggs, Ft. Myers has also experienced four straight years of reduced violent crime and lowered the crime rate to the lowest it's ever been.

Perhaps Digg's greatest attribute, however, is his ability to strengthen police-community relations. Thus, allowing Diggs an opportunity to return to his native Toledo would come when the floundering Toledo Police-Community Task Force needs a total makeover.

Toledo, Ohio Issue 3 and Issue 4

The passage of Issues 3 and 4 keep Toledo operating and enable the City to fix roads in a way that it has not been able to do in the past. Passage has also allowed the City to channel federal dollars (through HUD's Neighborhood Revitalization Strategy Area program) into central city neighborhoods like Englewood and Junction, where plans have been "in the works" for some time.

Expect to see the power of the black vote also provide real change in Toledo's black neighborhoods.



The Most Valuable Democrat – Georgia's Stacy Abrams

It's hard to overestimate just how important Stacey Abrams' contribution has been and is to the Democratic Party's efforts to turn a Deep South red state blue in the recent presidential election and how important those continued contributions will be in the Party's efforts to attain a majority in the United States Senate.

Abrams is, among other things, the founder of the New Georgia Project, a voter registration group that reaches out to new voters in a variety of locations such as churches and college campuses.

Abrams, who lost a hard-fought, close election in 2018 for Georgia governor in a contest tainted by allegations of voter suppression, responded to that loss by founding Fair Fight 2020, which funds and trains voter protection teams in 20 states.

The result of those efforts is a Georgia presidential election in which Democrat Joe Biden won what has been previously recognized as a solid red state. No Democratic presidential candidate had won in Georgia since Bill Clinton in 1992. Biden has so far garnered more than a half million more votes than Hillary Clinton received four years ago.

Abrams recognized the state's growing population and changing demographics. Her narrow loss in 2018 also prompted her to found Fair Fight, write a book about voter suppression and produce an Amazon documentary, "All In: The Fight for Democracy." She passed on the chance to run for U.S. Senator and used her influence to fight the voter suppression regulations that had been put in place by then Secretary of State Brian Kemp. She helped register, by some estimates, more than 800,000 new voters for the 2020 election cycle.

Now, with a new president whom she helped to elect, she may well be con-





sidered for a high level post in the new administration or as chairman of the Democratic National Committee.

Abrams, one of Robert and Carolyn Abrams' six children, was born in Madison, Wisconsin and raised in Gulfport, Mississippi. The family eventually moved to Atlanta so that he parents could pursue graduate degrees at Emory University.

Her political career started early, in high school, when she was hired as a

Jen O'Malley Dillon Led the Democratic Presidential Campaign

Jen O'Malley Dillon served as the campaign manager for President Elect Joe Biden and Vice President Elect Kamala Harris' successful 2020 race – the first woman to head a Democratic campaign for president.

The Massachusetts native, earned a bachelor of Arts degree in political science from Tufts University

The 44-year-old's first experience in presidential campaigns was in 2000, when she worked as a field organizer for Al Gore, before she was promoted to a regional field director by the end of his unsuccessful run.

She then worked on John Edwards' 2004 and 2008 unsuccessful campaigns, before she served as the deputy campaign manager for former President Barack Obama's successful reelection campaign in 2012.

In 2013 Dillon founded Precision Strategies, "an integrated strategy and marketing agency working with companies, causes and candidates to change people's minds and move them to action," according to its website.

Dillon focused a large portion of the Biden campaign on the "blue wall" states of Michigan, Pennsylvania and Wisconsin that Trump narrowly won in 2016. Biden ended up winning all three states, giving him a crucial 46 electoral college votes.

Biden visited Pennsylvania 13 times during the campaign, which was

three more times than any other state, and a Biden insider said of Dillon's strategy: "That's what Jen does: see the main opening and make sure every detail is in place to follow through.

Ben LaBolt, who was a colleague of Dillon's while she worked for Obama, added that she is a "master."

"Jen is a brilliant strategist who knows the battleground states like the back of her hands, and who knows the Democratic Party mechanisms and infrastructure down to what type of data infrastructure needs to be built to reach persuadable voter," he said.

speechwriter for a congressional campaign.

Abrams earned a bachelor's degree from Spelman College in interdisciplinary studies while working in the youth services department of the office of Atlanta Mayor Maynard Jackson. She studied public policy at the University of Texas, earning a master's degree and then a law degree from Yale Law School in 1999.

In 2002, Abrams was named deputy city attorney for the City of Atlanta and, in 2006, made her first run for elected office winning a seat in the Georgia House of Representatives for the 89th district. In 2010 the Democratic caucus elected her minority leader.

During her time in the House, Abrams was instrumental in saving the HOPE Scholarship program, which provides scholarships to Georgia students, stopping the largest tax increase in Georgia history, according to one national magazine. She also worked on criminal justice reform that reduced prison costs without increasing crime and helped put together the state's largest ever public transportation funding package.

She resigned her seat in 2017 to start her campaign for governor. Abrams won the Democratic Party nominating contest becoming the first black woman to become a major party's candidate for governor in the U.S. Her Republican opponent was Kemp, still the Secretary of State. Between 2012 and 2018, Kemp's office had cancelled over 1.4 million voter registrations, most of them after Kemp had stated his intention to seek the governor's office.

Then, a month before the general election, more than 53,000 voter regis-

Going Forward! It's Time to Get Back to Work

The people used their voices on November 3, 2020 to change the leadership of our government at the local, state and federal levels. I am grateful for those voters in Ohio District 44 who will allow me to represent them again in Columbus, Ohio at the statehouse. Everyone was focused on the presidential election. (And rightly so, I might add). Now, with my colleagues and I returning to Columbus this week for various committees and then starting the "lame duck" session before the end of the legislative session, we have a lot of unfinished business to deal with.

Unfortunately, with the results of the state elections and some legislators not returning for a new term, this will be the time when those legislators will be pushing to get their legislation passed. I am told to expect a flurry of legislation, back-to-back committee meetings and long sessions to pass legislation before we recess. This time between now and the end of this year, is called a lame duck session.

There are several pieces of legislation that could have major impact on Ohioans.

The Fair School Funding Plan is the Ohio Senate's companion bill to the Cupp-Patterson Bill to reform the way the public education (K-12) is funded in Ohio. This bill is in response to the Ohio Supreme Court finding that the way Ohio funds public education is unconstitutional. It creates a formula to reallocate school funding between local and state government.

The repeal of HB 6 which was passed to provide First Energy with a bailout. This legislation has been tainted by the corruption scandal of former Speaker Larry Householder. There are currently three bills addressing this. Two bills are seeking to outright repeal HB 6. The third bill seeks to remove some of the terms affecting the energy efficiency and alternative. There were several committee hearings held, but there doesn't seem to be any movement either way right now.

There are several bills seeking to help citizens during this pandemic:

HB 578 Provides support for homeless shelters and provide rental assistance for renters who are affected by COVID. HB 599 would require notice to emergency workers, medical service workers or funeral workers who have treated, handled or transported a patient who tested positive for Covid-19. HB 633 makes COVID-19 contracted by specified types of employees an occupational disease under the Workers' Compensation. Or HB 593 which would provide paid leave to quarantined/compensate contract workers, if passed.


This is just a small sample legislation that has been introduced in the Ohio

House. Once a bill is passed from the House, it then must go through the same process in the Senate. The bill becomes law when the Governor signs it. Considering the short timeframe, it will be very interesting to see what bill the current Speaker John Cupp will set for the agenda.

Just as your voice became your vote. You can still your voice in the legislative process. If you want to watch committee hearings and the legislative sessions, you can through the Ohio Channel, which now broadcast those meetings. You can also send comments, call or write to me and other legislators about your opinion on the bills. It is so important that you continue to use your voice. Democracy is a participatory sport and your voice needs to be heard.

The Englewood Community Fireside Chat

Englewood District community leaders facilitated a virtual fireside chat on Friday, November 6, 2020 to discuss economic development and neighborhood improvement ideas. The fireside chat was led by Kathleen Greely of Community RE Invest Coalition and included panelists: Brandon Sehlhorst, Toledo Commissioner of Economic Development; Sandy Spang, Toledo Commissioner of Business Services; Rev. Donald Perryman, PhD, Center of Hope pastor; Vanice Williams, newly appointed City of Toledo District 4 councilwoman.

Facilitator Greely explained during her opening remarks that the fireside chat was organized in response to remarks from the virtual community meeting and conversation that was held to discuss the redevelopment of Englewood and Junction.

"We had a community conversation last week and we're curious to discuss several topics tonight. This fireside chat provides an opportunity to meet and talk on a personal level about economic development and small business development. We received so much feedback from attendees of our last meeting and one key remark was that we didn't receive enough feedback from city council and resources for businesses," explained Greely.

According to Greely, the coalition was formed in response to the City of

Toledo's five-year consolidation plan and includes current and former residents who have concerns about the community. The coalition attendees met with City of Toledo Department of Neighborhood staff prior to the fireside chat and expressed dissatisfaction. "We met with neighborhoods last week and half of us were asking why we weren't included in the five-year plan."

Councilwoman Williams briefly introduced her connection to that neighborhood and encouraged the coalition to reengage with Department of Neighborhoods.

"Thank you for putting this on. I grew up in the area around Smith Park. I grew-up an at-risk youth with elders who pushed me but didn't know how. I know I am a community kid, and that's why I walk my neighborhood now. I had a lot of people fighting for me, that's why I fight for these kids now. The plan was created for the entire city. The Department of Neighborhoods should be on each chat. We have a great director, Rosalyn Clemens.

She is amazing and she has an amazing staff," said Williams.

The virtual fireside chat discussion switched to economic development and began with Sandy Spang listing available resources. "One of the major obstacles is the condition of commercial buildings that need to be brought up to code following an owner change. We're talking electric, plumbing, heating, etc. We have programs that can help with those changes too," said Spang.

In addition to the small business resources, Brandon Sehlhorst explained the similarities and differences between his role and Spang's role. "We both work to eliminate barriers and obstacles to start a new business. My focus is export businesses that could locate anywhere in the city but select Toledo. These businesses will bring new money to our area, employ more people, and provide skilled labor and good work for our residents. The city of Toledo has water, air, roads and rails as access points, which makes us competitive for opportunities," said Sehlhorst.

Selhorst continued the discussion by providing the coalition with steps to assist with economic development. "This organization can assist the City of Toledo by assisting investors to know what properties are available and what is for sale. We struggle with keeping a current inventory, so we can eliminate barriers and overcome challenges with properties. That way once a property has been identified, we can ensure the space is ready for businesses and connect the invest to the community's vision," said Selhorst.

In the coming weeks, the coalition plans to host another virtual fireside chat that will include the

As you may know the Toledo Public School District began the 2020-2021 school year in the "Red Light" status, meaning virtual learning only. This meant the virtual needs for the students were top priority. Many families in the district were working off of limited internet access and/or one Chromebook during the spring semester.

Toledo Public Schools serves approximately 23,000 students Pre-K through 12th grades. With 90 percent of the 8,100 families qualifying for free or reduced lunches because of their income levels, many of the families lack internet services or devices to participate in online learning.

With the assistance from the TPS Foundation, the district was awarded a \$50,000 grant from Fifth Third Bank to address the virtual needs of Toledo Public Schools students on free or reduced lunch and/or families of three or more.

the first quarter of 2020. The genesis and the idea of reinvesting in the Dorr Street Corridor took us straight to asking the question of why the low vibration still looms over this district, even though the City of Toledo, Department of Neighborhoods recently introduced a five-year Plan, including over \$37M in programs and services, 55-60% specifically for the Englewood/Junction District.

Due to unkept promises and remnants of urban renewal that have left this neighborhood underdeveloped for the past forty plus years; I am joined by several community residents and esteemed leaders, clergy and concerned citizens who chose a commitment to reinvest time and resources in the SW division. CRC-ESW seeks to improve the socioeconomics, financial literacy, homeownership, generational wealth conversations and a quality of life for youth and families in the Englewood District, specifically Englewood SW.

Community reinvestment starts with transforming the conversation. What has not worked since the 70s over here, and why? What structures or property acquisition would allow us to reinvest in our community, today, and be used to foster collaboration in the Englewood district in 2021, and beyond? Can financial literacy, generational wealth conversations, and a better understanding of how to use Land Bank and LISC make a difference for residents? Can someone explain "What is an Opportunity Zone", and how do we benefit from the opportunity?

Urban Renewal was partially an attempt to connect suburbs to downtown in a faster way, which resulted in tearing up our neighborhoods in part or in some cases isolating other neighborhoods. We can start to see great things happen in downtown Toledo, how do we start a conversation that builds off that momentum and targets our neighborhoods still affected and neglected today because of urban renewal?

Lucas County Commissioners & Toledo Regional Chamber of Commerce Small Business Stabilization Fund Approve Additional \$500,000

The Lucas County Commissioners last week approved allocating an additional \$500,000 to the Small Business Stabilization Fund that was created a week ago to provide financial assistance to businesses and non-profit organizations that are struggling as a result of the COVID-19 pandemic.

The Commissioners took action to provide the additional funds due to the overwhelming response from area businesses and non-profit organizations for assistance. The \$500,000 appropriated by the Commissioners on Tuesday brings the total amount of the funds available for distribution to businesses and non-profit groups to \$2 million. The program provides qualified businesses and non-profit organizations with fewer than 50 employees with grants up to \$25,000.

As of Tuesday, the Toledo Regional Chamber of Commerce, which is administering the Small Business Stabilization Fund program, had received over 400 applicants seeking nearly \$5 million in grant assistance. Qualifying small businesses and non-profit organizations submitted applications to the Chamber of Commerce for reimbursement of certain eligible expenses. All program funds must be expended by December 30, 2020.

Of the businesses requesting assistance, nearly 50 percent are minority, women, or veteran owned, surpassing the cumulative participation rate of 15 percent set by the Commissioners.

The web portal to submit applications for the first-come, first-served program has now been closed. However, the Chamber of Commerce is continuing to process applications. Those applicants that were not funded will

remain in the queue in the order of receipt should additional funding become available.

The Ohio Development Services Agency is administering two new targeted programs to address the tremendous need for small business aid in Ohio: the Small Business Relief Grant and the Bar and Restaurant Assistance Fund:

The Small Business Relief Grant

Up to \$125 million in federal CARES Act funding received by the State of Ohio has been designated to provide \$10,000 grants to small businesses to help them through the current crisis. The program began accepting applications November 2, 2020.

Bar and Restaurant Assistance Fund

The governor has designated \$38.7 million in federal CARES Act funds to provide \$2,500 assistance payments to on-premise liquor permit holders to help them through the financial difficulties experienced during the COVID-19 pandemic. As these permit holders have not been able to fully use their liquor permits, their businesses have been negatively impacted. The program began accepting applications November 2, 2020.

tration applications were put on hold, of whom more than 75 percent were minorities.

Abrams lost the race to Kemp, who had also overseen the election in his official capacity as Secretary of State but she declined to pursue the matter through legal action. Her high profile campaign has made her a prominent figure nationally. She was selected by Minority Leader Sen. Chuck Schumer to give the rebuttal to the State of the Union address in January 2019; she decided not to run for the Senate and then founded Fair Fight 2020.

"I had two messages," she said during an interview with CNN last week. "One, voter suppression is real and we have to have a plan to fight back. Two, Georgia is real. You've got to have a plan to fight there. We were privileged to know that by the time Joe Biden won the nomination, he had Georgia on his mind."

But the election season is not nearly over for Abrams in Georgia. As a result of her efforts in getting more people registered and getting them to the polls, there are two critically important runoff elections for Georgia U.S. Senate seats in January.

In the regularly scheduled contest, incumbent Republican Sen. David Perdue failed to hold on to his early majority against Democrat Jon Ossoff. Perdue finished with 49.8 percent of the vote.

In the special election, Rev. Raphael Warnock, the Democrat, finished with 32.9 percent of the vote and his two Republican opponents, Senator Kelly Loeffler and Doug Collins, with 25.9 and 20 percent respectively. Warnock, pastor of the famed Ebenezer Baptist Church in Atlanta – Martin Luther King, Jr.'s former church – will face Loeffler in the January runoff.

If the Democrats win both seats, they will have 50 total and effectively hold the majority position with incoming Vice President Kamala Harris (who will also serve as president of the Senate) to break ties.

Should that happen, Abrams will have earned a lion's share of the credit.

Statement from Toledo Public Schools Administration

Ohio Gov. Mike DeWine has said that 80 percent of Ohioans live in a county that is considered to have a high risk for spreading COVID-19, including Lucas County. As cases continue to increase across our county, the state of Ohio and the country, Toledo Public Schools will return to 100 percent remote learning (known as Red Light status).

While the number of confirmed cases of students in schools – specifically TPS schools – remains low, we are concerned that trend will not continue as we approach the holidays and the colder winter months and the most prudent course of action is to have all of our students learning remotely. Here are the details:

- Thursday, November 12 will be the last day of in-person instruction for all Group A students in grades Pre-K through fifth; students will need to take home all personal items that day.
- Friday, November 13 will be the last day of in-person instruction for all Group B students in grades Pre-K through fifth; students will need to take home all personal items that day.
- Sixth, seventh and eighth grade students who were scheduled to return to school on Monday, November 16th will continue with online learning.
- TPS will remain in Red Light status at least through the end of the first semester, which ends on Thursday, December 17.
- Students from TTA and ANSAT will continue with in-school instruction so they can earn their industry credentials.

That means that any student who is currently on the A/B hybrid schedule will return to remote learning and the remainder of our students – including the sixth through eighth grade students who had been expected to start on the hybrid schedule on the 16th – will continue with their online learning.

We will follow this schedule through the end of the first semester, which ends on Thursday, December 17, 2020 – students will then transition to winter break on Monday December 21, 2020. Friday, December 18, 2020 is teacher workday. A decision about the second semester will be made over the Christmas holiday break.

This return to all remote learning is being made with one concern in mind the health and safety of the district's students and staff members. While administrators are thankful confirmed COVID-19 cases have been low in TPS schools, they want to ensure the district does not contribute to growing cases in the county. We will continue to closely monitor the data provided by the Toledo-Lucas County Health Department and the Ohio Department of Health to make an informed decision before school resumes on Tuesday, January 5.

Students will need to continue logging on to their Chromebook each day and complete their classwork. They must maintain their grades and daily attendance will be taken. This is the website to the district's Responsible Reopening plan for information related to expectations during Red Light status: tps.org/reopen

 - o The last day of in-person instruction for all Group A students in grades Pre-K through fifth; students will need to take home all personal items that day.
- Friday, November 13:
 - o The last day of in-person instruction for all Group B students in grades Pre-K through fifth; students will need to take home all personal items that day.
- Monday, November 16:
 - o All students return to remote learning
 - o Sixth, seventh and eighth grade students who were scheduled to return to school on this date will continue with online learning.
- TPS will remain in Red Light status at least through the end of the first semester, which ends on Thursday, December 17.
- Students from TTA and ANSAT will continue with in-school instruction so they can earn their industry credentials.

Transportation

- Transportation will continue to be provided for the special education students who will be provided in-school services.
- Parents will be contacted directly to confirm the time and locations for pick-up and drop-off





Ka-thumpa, ka-thumpa, ka-thumpa. that's what people heard all day, if they lived near Chicago's South side. It was "those boys" and their basketballs, doing "nonstop layups, all-net free throws, and sky-high jump shots."

Sure, they were talented boys. Everyone knew that but they were Black and there were not many options for them, so those boys joined a traveling team and they met Abe Saperstein. That was when things really started happening: it was Saperstein's idea to re-name the team the "Harlem Globetrotters," which made it seem like they'd dribbled everywhere around the world.

It was almost as if they already had: the team played ball nearly every night in small towns all over the country, but their style was different. Because people didn't like seeing any Black players beat the hometown White teams, the boys had to learn new tricks. They did a "One-finger ball spinning." They did their "Rapid-fire mini dribbling." People began to laugh, and they began to enjoy the show as the "Trotters" racked up wins.

But it wasn't all fun: there were lots of places where the Globetrotters weren't welcome. They couldn't get a drink of water just anywhere. Some hotels turned them away. Sometimes, they weren't allowed in restaurants.

And still, they played because they were athletes! Even when most

teams in the NBA wouldn't hire Black players, the Harlem Globetrotters were real winners on the court. They proved it by beating the Minnesota Lakers! They could beat anybody!

And then one day, "something incredible happened"....


Everything spherical in your house can be dunked. Your 5-to-9-year-old has proven that, so what next? Well, *Swish!* will give them baskets of joy.

With the kind of quick-paced, wild fun that you get at a Harlem Globetrotters game, author Suzanne Slade brings that fast action to the page with a story of racism, perseverance, and resilience. While there's a main focus on just one generation here – roughly the Depression years through the early 1950s – Slade proceeds to show the overall evolution of the team by including a timeline and additional material. She also briefly touches upon individual players, but not more recent ones, which may disappoint grown-ups; kids whose hands are practically glued to a round, dimpled ball won't notice that omission at all.

This narrative would be the lesser without artwork by Don Tate. Kids will love his movement on the pages; adults will have difficulty not hearing "Sweet Georgia Brown" in their heads. That makes *Swish!* fun, it's fast, and if there's a future NBA or WNBA fan in your house, your child will love it by the buckets.

Toledo Police Department Needs City Applicants for Next Class

The Toledo Police Department is seeking a few good men and women. In fact, the officers conducting the current recruitment process are asking city residents to start applying now for a class that will start in August 2021.

In order to ensure that Toledo residents have an inside track on the application process, the department has made it easier from both a financial and logistics standpoint for those in the city aspiring to serve and protect.

"The goal is to get as many Toledo Residents as possible," said Sgt Mike Kurjan in a recent discussion with The Truth. "So we have set up as many testing locations as possible, such as at St. Francis High School and the

MLK Plaza at the train station."

The benefits of serving as a Toledo police officer are many: over \$65,000 pay after 36 months; retirement pension, tuition reimbursement, opportunities for advancement; among others.

The current recruiters are Kurjan and Officers Geoffrey McLendon and Stephen Bates. Their task is to grow the pool of applicants in order to fill a class of 31 for next August and for a second class shortly thereafter.

Kurjan, McLendon and Bates signed up for recruitment duty in September – all from street duty – and will return to the streets in January. Their recruitment assignment enables the department to bring in new ideas and approaches from their previous assignments and interactions with the public.

The deadline to apply for the 2021 class is December 31, 2020. The deadline means that the written test must be completed as well as application forms. That information can be found at TPDHIRE.COM.

In previous times, the testing location was only at Owens Community College, a Perrysburg site that is obviously not easily accessible to all Toledoans. The test also came with a cost for applicants of \$55 because it is a contracted standardized test, used throughout the country. However, Toledoans showing a proof of city residency, will have the fee waived.

Applicants should be between the ages of 20 and 39 but for younger aspirants there is the Police Explorer Program for ages 14 to 21 if they have to wait for a period after high school.
